The Secretary (Home), Union Territory of Lakshadweep is pleased to offer a temporary post of **Constable (Executive)** Group-C Non Gazetted – Non Ministerial in India Reserve Battalion, Lakshadweep, Daman & Diu and Dadra & Nagar Haveli by Direct Recruitment to the following Candidates in the Selected list of Constable (Executive) as per the circular cited above, on level-3 in the Pay matrix (Revised), the Pay Band of Rs.5200-20200 plus Grade Pay of Rs. 2000/- (Pre-revised) with admissible allowance at Central Government rates issued from time to time, on the terms and conditions mentioned below:

The appointment is purely temporary and will not confer on him any title to permanent employment. The appointment is further subject to the provisions of Central Civil Services (Temporary Services) Rules, 1965.

::2::

The appointment will be terminated at any time without assigning reasons, thereof especially when he/she is found unsuitable for government service. The appointment carries with it the liability to serve in anywhere as per the direction of government of India. The individual will be on probation for a period of two years from the date of his regular appointment. The period of probation shall liable to be extended at the discretion of the Competent Authority.

The appointment is further subject to the production of a Certificate of Fitness from an Authorized Medical Attendant. No person who has entered into or contracted a marriage with a person having a spouse living, or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service, provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the another party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

This offer is, therefore, conditional on his signing a declaration in the form enclosed and submitting it to this Administration before appointment. In case he wished to be exempted from the operation of the said provision, he may furnish the full facts of his case to the Administration immediately to enable them to take a decision in the matter. On appointment, he will be required to take an Oath of Allegiance to the Constitution of India in the prescribed form enclosed. The appointment will be further subject to the production of attested copies of the following certificates/testimonials issued by the Competent Authorities.

- (i) A Character Certificate from the head of the educational institution last attended by him, duly attested by the Executive Magistrate.
- (ii) A Character Certificate from his employer if any.
- (iii) Certificate showing educational qualification, age etc.
- (iv) Caste Certificate in case of Scheduled Tribes candidate.
- (v) Medical Fitness Certificate.
- (vi) Oath of allegiance / faithfulness to Constitution of India.
- (vii) Declaration of marital status.

No travelling allowance will be allowed for joining the appointment.

In case they accepts the offer of appointment on the above terms and conditions, he should intimate the fact in writing to the Office of the Commandant, India Reserve Battalion, HQ Kavaratti immediately **within 30 days** from the date of issuance of this office order, failing which the offer made to him will automatically be treated as cancelled without any further notice to him.
