

TERMS AND CONDITION**

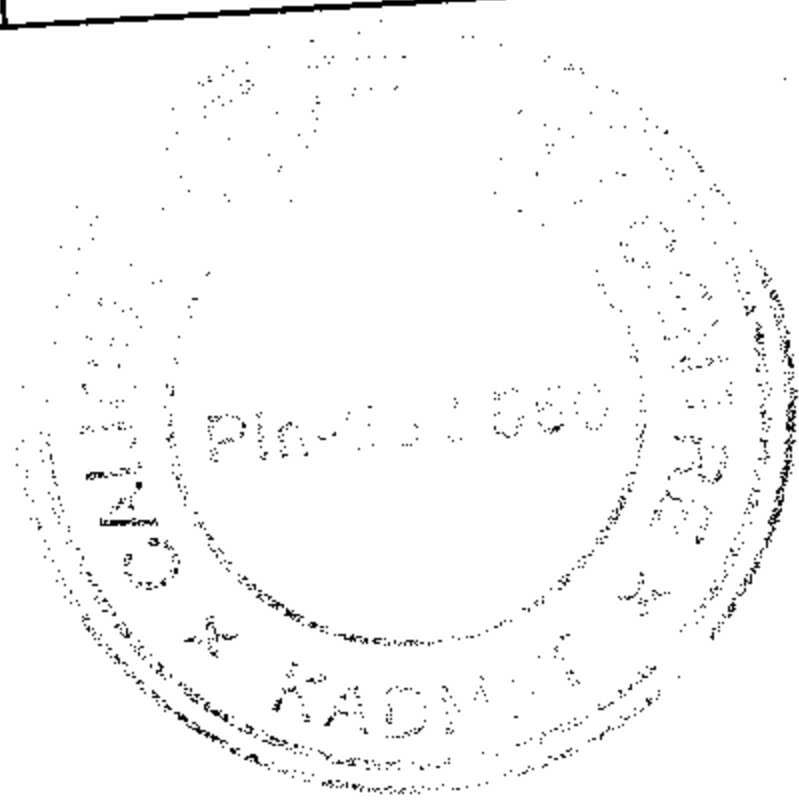
1. The list of items required and the specifications are furnished in the annexure attached
2. The cost of tender forms once paid will not be refunded. Tenders which are not in the prescribed form (attached) are liable to be rejected. The rates quoted should be only in Indian currency.
3. Sealed tenders with cost of tender Rs. 420/- (separate) and Earnest Money Deposit @ 1% of the cost subjected to a minimum of Rs.1500/- as crossed DD in favour of Finance officer, University of Calicut (cash/Cheque will not be accepted) should be forwarded to Principal, University Centre, Kadmat Island, Lakshadweep, pin-682556.
4. The rate quoted will be inclusive of all applicable taxes (GST), packing, insurance, transporting, handling charges and other incidental charges up to the Calicut University Centre, Kadmat, Lakshadweep. Rate if once accepted will be valid for a period of one year from the date of opening the tender.
5. Supplier shall be responsible for any loss or damages that may be occur on account of transportation etc.
6. Delivery of the entire quantity of materials ordered should be to the office of the University Centre, Kadmat Island, Lakshadweep within 30 days from the receipt of the supply order.
7. Request for enhancement of prices will not be permitted once they have been fixed.
8. Advance or part payment will not be made against the supplier under any circumstances.
9. Payment of the cost of items supplied will be made only after checking them by the authorized for the purpose and certifying the genuineness and specifications of the items satisfactorily.
10. If any item found defective it should be replaced by the supplier at his own risk and cost.
11. Lowest tender will be accepted subjected to branded quality of the items, ability and credibility of the bidder or firms to supply of the items in time.
12. Sealed tenders in the form specified should reach on or before date mentioned above.
13. The office reserve the right to reject any or all tenders without specifying any reasonable thereof.
14. The Company shall guarantee workmanship of the items offered to be free from any technical defects for a period of one year. Any defect in materials and workmanship discovered either at the time of the receipt of the items or in the course of the actual use, shall be duly replaced by the Company at their cost within one month from the date of intimation.


