Kavaratti: The Hon'ble Administrator, Shri.Farooq Khan laid foundation stone of Dr.A.P.J.Abdul Kalam Memorial Marine Bio Diversity Park at Kavaratti Island on 22nd February 2019. The protected budget for the medicinal and other coral parks is 25 crores and it will be made in the area of about 10900 Sq. meters. The "Marine Bio-diversity Park is the initiative of our Hon'ble Administrator Shri. Farooq Khan. Which is first of its kind in India and it is going to fulfil the objective of safeguarding the coral and the entire environment of the coastal area health".

The Lakshadweep is considered as one of the world's most significant atoll coral reef marine eco system, representing a major stage of the earth's evolutionary history (Islands) and significant habitats where rare and endangered, endemic marine species still survive. The Islands are home for more than 5000 marine species, many of them are found nowhere else on earth, and includes pristine coral reefs, green

turtle nesting and feeding habitats and primary and nesting habitat for Sooty and Noddy terns in Pitti Island.

Dr.A.P.J. Abdul Kalam Memorial Marine Bio Diversity Park is the outcome of International Conference on Status and Protection of Coral Reef, 2018 at Bangaram Island and stakeholder consultation of Union Territory Administration on 12th February 2019 at Kavaratti Island. The STAPCOR, 2018 agreed the global destruction of marine environment and biodiversity loss threatening all forms of life

including pristine coral reefs around the Islands. It is also envisaged that humankind is currently on an unsustainable path that involves a continuing steep loss of biodiversity with cascading consequences for nature and for human society, including in the global economy, the availability of food and water, and human security, health and wellbeing. To combat the crisis, especially in small islands like Lakshadweep, participatory process for developing biodiversity framework include Marine Bio Diversity park

proposed. The present plan of Marine Bio Diversity Park spans about 3900 Sq.m area with natural sea water pool in the location. A total of 125 crore is expecting to complete the project with a time frame of one year.

Dr.A.P.J. Abdul Kalam Memorial Marine Bio Diversity Park, Kavaratti will serve as dedicated site for marine conservation research with facilities to promote species recovery and habitat enhancement. Programmes will be conducted to facilitate visits for schools, institutes and organisations to learn

about marine research and initiatives that are carried out in Lakshadweep waters. There will also be a marine biodiversity pond, Marine interpretation centre, shark pool, marine animal rescue centre, Dinosaur park, and marine laboratory. The marine bio diversity pond will provide a dedicated in situ facility to receive, nurture and develop endemic coral species that may help to re-transplant to natural eco system, if any man made/natural hazards hampered the coral reef in future.

The Dr.A.P.J. Abdul Kalam Memorial Marine Bio Diversity Park, Kavaratti will serve as a platform for conservation, outreach and education. The marine bio-diversity pond, marine interpretation centre and shark pool provide the public more opportunities to learn about Lakshadweep rich marine bio diversity and contribute to marine conservation efforts.

Chief Conservator of Forest (APCCF), Ministry of Environment, Forest & Climate Change was the guest of the inaugural programme. Shri. R. Mihir Vardhan, IAS, Advisor to Administrator, Shri.
