## Mohammed Faizal P.P. of NCP won the Parliamentary constituency in Lakshadweep

**Kavaratti:** The result of 17<sup>th</sup> General Election to the Lok Sabha was declared on 23<sup>rd</sup> May, 2019 all over India. Shri Mohammed Faizal P.P. of Nationalist Congress Party won the 17<sup>th</sup> Lok Sabha election by securing 22851 votes by defeating Indian National Congress (INC) candidate with a margin of 823 votes. The Counting process started at 8.00 AM at Govt. Senior Secondary School Auditorium, Kavaratti. Initially, 149 Postal Ballots were counted and entire counting process ended with six rounds of Electronic Voting Machine

**New Delhi :** The nation pays homage to first Prime Minister Pandit Jawaharlal Nehru on his 55<sup>th</sup> death anniversary today.

Former Prime Minister Dr Manmohan Singh, UPA Chairperson Sonia Gandhi, former Vice President Mohammed Hamid Ansari and Congress President Rahul Gandhi paid tributes to Pandit Nehru at his memorial

Shanti Van in the national capital.

An all-religion prayer meeting was organised at the memorial premises.

Prime Minister Narendra Modi also paid tributes to Pandit Nehru on his death anniversary. In a tweet, Mr Modi said, the people of the country remember his contributions to the nation.

## First session of 17<sup>th</sup> Lok Sabha likely from June 6

**New Delhi :** The seventeenth Lok Sabha's first session is likely to start from June 6 and go on till June 15.

The dates of the first Parliament session are expected to be finalised during the first meeting of the new Cabinet on May 31<sup>st</sup>.

A day after Narendra Modi takes oath as prime minister of the country for a second term.

President Ram Nath Kovind will address the joint sitting of the two houses of Parliament on June 6<sup>th</sup>, the first day of the

session. A pro-tem speaker of the Lok Sabha is also likely to be appointed the same day.

The pro-tem speaker will administer the oath of office to all the newly elected MPs before the speaker's election.

Following the appointment of the speaker, both Houses will take up the motion of thanks on which Prime minister will give his reply.

The president will administer the oath of office and secrecy to Mr.Modi and other members of the Union council of ministers during a ceremony at the Rashtrapati Bhavan on Thursday at 7 pm.

## Narendra Modi to be sworn-in as PM for 2<sup>nd</sup> term on May 30

**New Delhi :** Narendra Modi will be sworn in as country's Prime Minister for the second term on Thursday. President Ram Nath Kovind will administer the Oath of Office and Secrecy to Mr Modi and other members of Union Council of Ministers at a function in Rashtrapati Bhavan. The event will take place in the evening at 7 PM.

A I R correspondent reports that after the landslide victory in the Lok Sabha polls, Mr Modi has been elected unanimously as the leader of the National Democratic Alliance yesterday. Later, he called on the President

and staked claim to form government at the Centre.

The new Cabinet of Narendra Modi is expected to have representation of all states and regions, especially from West Bengal and Odisha where BJP has performed well.

Several ministers of previous government are likely to retain their place in the Cabinet this time as well. Prime Minister has asserted that his government is even more determined to fulfill the dreams of 130 crore Indians and create the New India that they have dreamt of.

## Sri Lankan navy launches extra vigil over terrorists

**New Delhi :** Sri Lankan navy has launched extra vigil on its northern seas in wake of media reports that some terrorist elements may have left the country to land on Indian shores.

Navy spokesman Isuru Desapriya told our correspondent that the vigil is being carried out based on media reports but there has not been any such from security agencies.

He said special security plan is being implemented since Easter Sunday attacks and several naval units have been deployed to prevent any illegal movement of personnel and goods.

Earlier, several media outlets reported

that a group of 15 suspected Islamic State terrorists were fleeing Sri Lanka towards the Kerala Coast. Coastal security has been beefed up across the Kerala coast in wake of reports.

The spokesman said they are in touch with Indian authorities and the naval presence in the North has been doubled and placed on maximum vigil.

Indian intelligence had provided inputs about the Easter attacks which killed 258 people including 45 foreigners. A suspect was arrested in Kerala after the attacks and was believed to be following the literature propagated by Zahran Hashim, the main perpetrator of Easter attacks.

## Ban ROs where dissolved solids in water below 500 mg/litre, NGT tells govt

**New Delhi :** The National Green Tribunal, NGT, has directed the government to ban water purifiers where total dissolved solids (TDS) in water are below 500 mg per litre. A bench headed by NGT Chairperson Justice Adarsh Kumar Goel passed the order after perusing a report of a committee formed by it, and gave the directions to the Ministry of Environment and Forests (MoEF).

The tribunal also directed to sensitise public about the ill

effects of demineralised water and asked the government to make it mandatory to recover more than 60 per cent water wherever RO is permitted across the country.

Reverse Osmosis (RO) is a water treatment process that removes contaminants from water by using pressure to force molecules through a semipermeable membrane.

It also ordered that directions be issued for enforcement of Extended Producers Responsibility

by the manufacturers for disposal of cartridges and membranes and directing manufacturers to provide proper labelling on the purifier specifying that the unit should be used if TDS is more than 500 mg per litre.

The Tribunal was hearing a plea filed by an NGO seeking conservation of potable water by preventing its wastage on account of unnecessary use of Reverse Osmosis (RO) systems.
