Govt issues EOI for shortlisting Strategic Partners for P-75(I) Project of Indian Navy

New Delhi: As a major initiative towards Make in India, the government has issued the Expression of Interests for shortlisting of potential Indian Strategic Partners for construction of six conventional submarines for P-75(I) Project of the Indian Navy. The project cost is about 45 thousand crore rupees.

It is the second project being undertaken under the latest Strategic Partnership Model, with the first being the procurement of 111 Naval Utility Helicopters.

The Ministry of Defence in a statement said, the decision will provide a major boost to the indigenous design and construction capability of submarines in India, in addition to bringing in the latest submarine design and technologies as part of the project.

The case was approved by the Defence Acquisition Council on 31st January this year. The Expression of Interests for shortlisting of Indian Strategic Partners has been uploaded on the Ministry of Defence and Indian Navy websites. The Expression of Interests for shortlisting of Original Equipment Manufacturers (OEMs) will be issued in two weeks.

Lander and rover meant for Chandrayaan-2 reaches ISRO's launch pad at Sriharikota

New Delhi: The lander and rover meant for India's second lunar mission Chandrayaan-2 reached the ISRO's launch pad at Sriharikota last night.

The rover called Pragyan is installed within the lander known as Vikram. They were flagged off from ISRO laboratory in Bengaluru on Monday.

Earlier, the orbiter that will house the lander and the rover reached the launch pad at the Satish Dhawan Space Center, Sriharikota on Saturday.

Chandrayaan-2 will be launched aboard India's most powerful booster GSLV-Mark-3 tentatively early in the morning on July 15th with the aim of making the lander to soft-land on the South Pole of the moon by September 6th. India would be the fourth country to have its probe soft-land on the moon.

"As the orbiter, lander and the rover of Chandrayaan-2 are all in the launch pad in Sriharikota, the scientists of the national space agency are now assembling them together. Later, Chandrayaan-2 will be integrated with the rocket GSLV Mark-Three for its launch as per schedule.

The rover, the lander and the orbiter, all have payloads meant for collecting data on the nature of the moon surface. Once the orbiter reaches the lunar orbit of 100-kilometre distance from the moon, the lander will emerge from it and make a slow descend on the lunar south pole.

Once it softlands, the rover will leave the lander and move around the moon's surface, collect samples and analyse them. The lunar south pole remains an unexplored area so far and Chandrayaan-2 is expected to unravel some of the mysteries of the earth's only natural satellite.

FM Nirmala Sitharaman to hold Pre-Budget consultation with Finance Ministers of various states

New Delhi: Finance Minister Nirmala Sitharaman will hold Pre-Budget consultation with the Finance Ministers of various States in New Delhi today.

Earlier, Ms Sitharaman had held pre-budget consultation meetings with economists, representatives of

the social sector, infrastructure sector, agriculture and rural development sectors, financial sector and capital markets.

The Union Budget for 2019-20 will be presented in Parliament on the 5th of next month.

Three Young space 'scientists' get call on on ISRO programme

Kavaratti: As the ISRO's young scientists programme, Yuvika 2019, kicks off on May 13th, the three students selected from the Union Territory of Lakshadweep for it are a jubilant lot and are looking forward to pick basic lessons on space science, besides having a glimpse of the space research organization's centres and meeting up with space scientists. The programme concluded on 27th May 2019.The space agency chooses three studens from Lakshadweep for Yuva Vigyani Karyakram, first of its kind interaction programme for middle school students started by union governments vision " Jai Vigyan, Jal Anusandhan".

The two week residential programme

was inaugurated by ISRO Chairman at Sri Harikotta on 13th May, 2019.

The three students, Amana Akbar, Fathima Z and Radhil R are among the 110 middle school students from 29 states and 7 Union Territories who have been selected for the programme from across the country. As many as 24 students would complete the programme at the Vikram Sarabhai Space Centre (VSSC), one of the four nodal centres for the programme.

VSSC deputy Director CR Thomas said:"As announced by Isro chairman K Sivan, the two-week long programme held from May 13-26 covered the basics of space science and technology, besides giving a chance to the students to interact with scientist and visit ISRO facilities."

Amana Akbar, a IXth standard students of Govt Senior Secondary School Minicoy, Fathima Z another IX std student of Govt Senior Secondary School Kavaratti and Radil R Mahathma Gandhi Senior Secondary Scool Andrott said: "We are so happy to become in the team. All are very friendly here. Three of us are from Lakshadweep, while others are from different parts of the country. There was ice-breaker session led by retired space scientist VP Balagangadharan and the participants introduced themselves. It was interestingand remarkable experience" they said.

Government taking various steps to make BSNL and MTNL a profitable organization: Ravi Shankar Prasad

New Delhi: Union Minister of Telecommunications Ravi Shankar Prasad assured the Parliament today that the government is taking various steps to make the two public sector organizations, BSNL and MTNL to make it a profitable organization and also more competitive when compared to the private players in the field.

Answering to host of questions raised by various members on the issue related to the state of affairs of the two organizations he said that, to improve quality of telephone wireline network. BSNL is replacing Legacy Public Switched Telephone Network (PSTN) switches to Next Generation Network (NGN) which support a different kind of services i.e. voice, video and data.

With the migration to NGN, Minister said that the customer will get enhanced Value-Added Services on wireline like Personalized Ring Back Tone, Multi Media Video Conferencing, IP Centrex, Limited Fixed Mobile Telephony (LFMT) and

Admitting that these organizations face stiff competitions from private players, Minister said that the BSNL has a larger workforce and their interests are also need to be taken care of. Minister also said that only the BSNL was offering free services in the areas where the natural calamities took place.

He allayed fears of the members that the interests of these organizations were compromised for favouring private players. He said that in rural areas it is only the BSNL that reaches out.

Govt develops National Strategic Plan to eradicate TB by 2025

New Delhi: The government has developed a National Strategic Plan with the goal for ending Tuberculosis (TB) by 2025.

In his reply to a question in the Lok Sabha, Minister of State for Health and Family Welfare Ashwini Kumar Choubey said, India accounts for 27.4 lakh estimated new TB cases annually, which is the highest in terms of absolute numbers.

He said, the estimated cases of TB in the country is 204 per lakh population for the year 2017 as per the last year's Global TB report. However, India ranks 35th in the world in terms of TB cases per lakh population. Over 5 lakh 62 thousand patients were cured of TB last year.

Samant Goel appointed new chief of RAW

New Delhi: Punjab cadre IPS officer Samant Goel has been appointed new chief of Research & Analysis Wing. Assam Cadre IPS officer Arvind Kumar will be new Director of Intelligence Bureau. While Mr Goel

played a key role in planning the February 2019 Balakot airstrikes and the 2016 surgical strikes, Arvind Kumar is known as the government's Kashmir expert. Both are IPS officers from 1984 batch.
