**NOTIFICATION**

The Principal (ITI), UTLA proposes to conduct a **Walk-in-Trade Test** for the qualified local candidates of Lakshadweep for engagement to the following posts on contractual basis in Govt. ITI, Kavaratti initially for a period of one year and extendable based on the performance evaluation by the Competent Authority deemed fit. 

**Selection Criteria :** The selection criteria in respect of post mentioned in Sl.No. 1, 2 & 3 shall be done based on 60% marks in Essential Qualification, 10% marks for Desirable Qualification (if any) and 30% marks for Walk-in Trade Test conducted by the Department (separate Trade Test shall be conducted by the Department for skill/endurance oriented posts).

The interested eligible candidates may attend the **Walk-in-Trade Test** to be held at ITI (New Campus) on **10.09.2019 at 10.00 AM** along with their original testimonials including a set of duly attested copies of testimonials and CV for Office records. The crucial date for age determination shall be the date fixed for the Walk-in-Trade Test i.e. **10.09.2019**. The selected candidates have to execute a contract agreement thereof.

The UTLA shall not arrange any conveyance particularly for the transit of eligible candidate(s) for attending the Walk-in-Trade Test as above from respective Island to Kavaratti. Therefore, the candidate shall individually manage their transit mode for the purpose.
