Scope of Work


1. The bidders have to provide repair and maintenance of the main engine of the dive boat given in the Annexure- 2 attached herewith.
2. The bidders are required to quote only for the items given in the Annexure -2 now and any repair and maintenance of additional items will be paid on a pro rate basis. The bidders may quote their rate after inspecting the boats is available at UTL Berth, behind FCI Godown, Willington Island, Kochi.
3. If any other minor work if noticed while repairing that also be carried out after consultation with the supervisor deputed from the undersign.
4. The repair and maintenance of main engine works should be as per the OEM. Successful bidder is responsible for complete repair works of the engine as per OEM recommendations.
5. While carrying out the repair works of the engine, if it is found necessary to replace any part or spare not covered under that also be carried out after consultation with the supervisor deputed from the undersign.
6. The firm undertaking the repair and maintenance has to replace such item. The firm has to make its own arrangements for spares/ tools/ measuring equipments/ transportation of personals/ loading and boarding of personal any other facility required to provide the repair works to the engine.
7. After completion of the repair work, the firm should demonstrate boat in running condition.
