

Persons/Firms, interested to purchase above vehicle, may submit their highest quotation in the enclosed Performa, addressed to the **District Agricultural Officer, District Panchayat (Agriculture), Kavaratti latest by 3.00 pm in or before 24th February, 2020.** The quotations received will be opened by the bidder Evaluation Committee at 5.00 pm on the same day ie.25.02.2020 in the presence of the bidder or their representatives present at the time. The vehicle is available " As is where is" for inspection from 10.00 am 5.00 pm on all working days, which is parked in front of Directorate of Agriculture building.

Terms & Conditions:

- The quotation shall be submitted in prescribed format only.
- The tenders shall be submitted in sealed cover containing tender form and EMD. A Demand Draft payable at Syndicate bank Kavaratti for Rs.1800/- drawn in favour of District Agricultural Officer, District Panchayat (Agriculture), Kavaratti shall be submitted along with tender form as EMD. Quotation received without EMD will not be entertained. No Cash/ Cheque will be accepted.
- The cover shall be prominently superscripted with "Quotation for purchase of condemned vehicle" and addressed to the District Agricultural Officer, District Panchayat (Agriculture), Kavaratti.
- The vehicle will be disposed by public auction, if required.

- e) Price quoted by the bidder should not be less than the reserved price fixed for the vehicle by the authority.
- f) If the highest bidder does not accept the offer of sale of vehicle for any reason ' what so ever it may be, their EMD will be forfeited and the second highest bid amount will be considered for sale subject to minimum reserve price conditions.
- g) The successful bidder shall deposit full amount in the Receipt Head of Department 0401 Crop Husbandry within 24 hrs. from the time of fixing the tender on his/her name, and the vehicle shall be removed from the premises of the Department , at his/her own expenses within 7 days.
- h) No guarantee for its worthiness/quality is given by the Department.
- i) The successful bidder will be responsible for getting Registration Certificate of the vehicle or any other documents as required by the RTO, in his name at own cost expeditiously. The Department/officer will not be responsible for any laps on his part in this regard.
- j) The EMD of the successful bidder will be released only after payment of bid amount. EMD will not be adjusted against the bid amount & will be forfeited, if the successful bidder fails to honor the bid.
- k) The EMD of unsuccessful bidders will be released immediately on finalization of the public Auction.
