



Terms and condition of the Quotation

1. The quotation/tender should be addressed to the Administrative Officer Lakshadweep Office, Willington Island, Kochi-682003.
2. The quotation should be super scribed as "**Quotation for Web Security auditing for Online Entry Permit System**" and should be reached to the above address by post before.16.11.2020 at 3PM.
3. Rate of the work must be quoted in Indian rupees only.
4. The EMD amount of Rs.1500/- shall be drawn by means of Demand Draft in favour of the Administrative Officer, Lakshadweep Office, Willington Island, Kochi and submitted along with quotation.
5. Participants of this quotation from CERT-In empanelled Agencies for the Security Audit should submit price bid and documentary evidence of empanelment like CERT Certificate, Registration Certificate etc along with quotation within the time frame.
6. After completion of the tender process, the department will place the work order for conducting Security Auditing. The successful vendor shall complete the auditing within the stipulated period of one month.
7. Delaying auditing may cause to cancel the work order forfeiting the EMD.
8. The lowest rate will accept subject to ability and credibility of the bidder.
9. Representation on rate once accepted will not be entertained during validity of contract period.
10. Payment will be made only after completion of work authorized and certified by NIC.
11. Advance or part payment will not be made.
12. Violation of the terms of tender notice will entitle cancel of record.
13. The UT Administration reserves the right to accept or terminate the contract at any time during the validity of contract. The decision on the same shall be final and no appeal shall be lie on it.
