

Terms and Conditions

1. The tender must be accompanied by the Earnest Money Deposit (EMD) of the total amount of Rs. 26,000/- by the means of Demand Draft in favour of Director, Women & Child Development U.T of Lakshadweep, Kavaratti payable at Syndicate Bank, Kavaratti.
2. 100% of the payment will be made on delivery of full quantity of articles to the Women & Child Development Office, Kavaratti.
3. Successful bidder shall submit Performance Guarantee/ Security Deposit separately for an amount of 5% of the value of the contract. PG/SD shall be submitted by means of bank Guarantee from any nationalized bank.
4. Time period: Goods intended in the confirmed supply order shall be supplied within 30 days from the issue of confirmed supply order.
5. The play materials shall be under warranty for a period of one years from the date of Supply.
6. If the supplier fails to supply the goods at point of supply within the stipulated time frame, LD @ 0.5% of cost of goods per week or part thereof subject to a maximum of 10% of the cost of goods for the delayed period will be charged from the supplier. The payment towards the cost of goods shall be released only after deducting the LD amount thus calculated.
