F.No. 2/4/2007-Services/1318 :- In exercise of the powers conferred by section 20 (1) of the Code of Criminal Procedure, 1973 (2 of 1974) read with Notification No. S.O. 183 (E) dated 20th March, 1974 of the Government of India, Ministry of Home Affairs, New Delhi, the Administrator, Union Territory of Lakshadweep is pleased to appoint **Shri. M.P. Abdul Kalam, AE, LPWD, Chetlat**, as Executive Magistrate with jurisdiction in the Island of Chetlat/Bitra and islet around the Chetlat/Bitra Island. **SHIFTING OF 20 BEDDED DEEN DAYAL UPADHYAYA AYUSH HOSPITAL FROM
PRIVATE RENTED BUILDING TO OLD GOVERNMENT ITI BUILDING AT KAVARATTI**

F.No. 1/35/2020-NAM :- In order to provide AYUSH Health Care facility under single umbrella, Union Territory of Lakshadweep Administration has identified old Government ITI building with land near main jetty premises for functionalizing Deen Dayal Upadhyaya AYUSH Hospital at Kavaratti. Accordingly 20 bedded Deen Dayal Upadhyaya AYUSH Hospital now functioning in a private rented building opposite to the State Bank of India shall be shifted to the above identified Government Building. AYUSH services (Out-patient and in-patient facilities in the stream of Ayurveda and Homeo) shall be made available for the public on completion of required alteration/renovations in civil infrastructure. This is as per the approval of Hon'ble Administrator, Union Territory of Lakshadweep.
