NOTIFICATION

F.No. 8/3/2018-E&F (P&L) :- In exercise of the powers conferred by sub section (2) of Section 5 read with sub section (29) of Section 2 of the Wildlife (Protection) Act, 1972 (Central Act 53 of 1972) and in suppression of all previous notifications except notification F.No.05/01/2020-CO, dated 19.03.2020 on the subject, the Administrator, Union Territory of Lakshadweep hereby authorizes all the Forest Officers not below the rank of Forester in the Department of Environment & Forest as Authorised Officer with immediate effect to exercise the powers provided under clause (b) of Section 55 of the Wildlife (Protection) Act, 1972, to lay complaints before the competent Court for taking cognizance of offence committed against the said Act within their respective jurisdiction as specified below.

F.No. 2/4/2007-Services /2562 :- In exercise of the powers conferred by section 20 (1) of the Code of Criminal Procedure, 1973 (2 of 1974) read with Notification No. S.O. 183 (E) dated 20th March, 1974 of the Government of India, Ministry of Home Affairs, New Delhi, the Administrator, Union Territory of Lakshadweep is pleased to appoint **Shri. A.E. Mohammed Naseem, Assistant Engineer, LPWD, Minicoy** as Executive Magistrate with jurisdiction in the Island of Minicoy and Islets around the Minicoy Island. He will exercise all or any of the powers exercisable by an Executive Magistrate under the said code.

The Administrator is also pleased to specially empower him to exercise the powers specified under section 107, 108, 109, 110, 133, 143, 144, 174 & 176 of the said code.

The Notification shall have effect from the date on which the officer takes over charge as Deputy Collector, Minicoy and remains till such period the officer holds the charge of Deputy Collector, Minicoy.
