

Notification of the social impact assessment on land acquisition for the construction of link road from concrete road to Govt. Junior Basic School at Kalpeni

With reference to the notification of Land Acquisition Collector vide F.No.34/36/2019-LR dated 28.02.2020 issued for Social Impact Assessment as per Sub rule 1 of Rule 3 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2014 in connection with the land acquisition for the construction of link road from concrete road to Govt. Junior Basic School at Kalpeni, Social Impact Assessment and Consent Society had been appointed M/S.Samaha GeoSolutions LLP, #1/2017 Dasooq, Kiltan as Social Impact Assessment Team for the said purpose as per the Rule 6 of the said notification. As per the Sub rule 5 of Rule 6, Shri.Tippu Sulthan among the said team is appointed as a team leader for liaison with Society and Land Acquisition Collector for the purpose of implementing the said Rules.

The team shall collect and analyse a range of quantitative and qualitative data, undertake detailed site visits, use participatory methods such as focused group discussion, participatory rural appraisal techniques and informant interviews in preparing the Social Impact Assessment Report. Therefore, all the effected people and surrounding stakeholders are requested to cooperate with the SIA team to provide relevant information to make a SIA report.

As per the Rule 8 of the said notification, the draft report will be made available to the Panchayath office for information. In continuation the public hearing will be conducted involving all the stakeholders and Panchayath and the concerns of all the stakeholders and Panchayath will be incorporated in the final report of the SIA.
