**DECLARATION**

WHEREAS, vide Preliminary Notification No. LAQ/SMC/PumpingStation/Sew.Sys./3/2019/16/2020 dated 14.01.2020, it was Notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule hereto (hereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for **Pumping Station of Sewerage System**.

WHEREAS, as required under sub section (2) of section 15 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, One objection was received by the Department from Shri Dharmendrasinh Karansinh Thakor to reduce the area of land to be acquired to 300 Sq.mt. instead of 405 Sq.mt. Silvassa Municipal Council has also agreed that 300 Sq.mt. will be sufficient for the project. Accordingly, a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu to proceed with the acquisition process and the same has been approved by the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu.

WHEREAS, the Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu is satisfied, on the basis of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the Rehabilitation and Resettlement Scheme shall be applicable because there are two families getting affected due to the proposed acquisition process.

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said lands are required for the public purpose, namely for Pumping Station of Sewerage System.

The Lands Statement and Plan can be inspected in the Office of the Collector, Dadra and Nagar Haveli, Silvassa during the Office hours.


