**ORDER**  
(u/s 133 Cr.PC, 1973)

**WHEREAS**, it has come to the notice of the undersigned that an outbreak of Avian Influenza or Bird flu cases has been reported in the newspaper and other media reports across 12 epicenters in at least 4 States viz. Kottayam and Alappuzha in Kerala (mostly poultry), Baran, Kota, Jhalawar regions in Rajasthan (Crows), Mandusaur, Indore, Malwa areas in Madhya Pradesh (Crows);

**AND WHEREAS**, it is expedient to make necessary arrangements to stop it from entering the Dadra & Nagar Haveli and take precautionary measures to contain the spread of Avian Influenza (A.I.) or Bird flu cases to prevent it from becoming a public nuisance;

**AND WHEREAS**, the undersigned is satisfied that the conduct of trade of poultry birds and keeping them unmonitored may be injurious to the health of the people in the District of Dadra & Nagar Haveli thereby making it a Public Nuisance;

**AND WHEREAS**, it is imperative to take necessary action in order to contain the spread of A.I. or Bird flu and remove this public nuisance in the interest of general public;

**THEREFORE**, in view of above and in exercise of the powers conferred under Section 133 of the Code of Criminal Procedure, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, 1973, hereby order as under:

1. The entry of all poultry and non-poultry birds from the States of Himachal Pradesh, Kerala, Madhya Pradesh, & Rajasthan shall be banned;
2. The entry of day old chicks, pullets as well as all ornamental / exotic birds from all State and U.Ts shall be banned.

The Superintendent of Police, D&NH, shall ensure that necessary security arrangements are made at Entry and Exit Points of the District of Dadra & Nagar Haveli.

Further, the Dy. Director (Transport), D&NH, shall ensure that the official posted at all the Check Posts shall ensure a thorough check of all the Commercial Vehicles to restrict the entry of above mentioned birds.
