ORDER
(u/s 133 Cr.PC, 1973)

WHEREAS, in the wake of outbreak of Avian Influenza or Bird Flu, this Office vide Order dtd. 08/01/2021 and dtd. 11/01/2021, referred in preamble (1) and (2), respectively, had banned the entry of all poultry and non-poultry birds from all the States, closed down the poultry selling frozen poultry items and advised all the Hotels to refrain consumption or sale/purchase of chicken related dishes in order to contain the spread of Avian Influenza or Bird Flu;

AND WHEREAS, the Department of Animal Husbandry & Veterinary Services, D&NH, reported to this Office that Avian Influenza is a virus that infects only birds and not human beings;

AND WHEREAS, it was also reported that the said virus gets destroyed at 70 degree centigrade within 3 second and thus, consumption of meat and egg properly cooked at 70 degree has no risk;

AND WHEREAS, it was further reported that selling of poultry products sourced from the non-infected areas/states etc. may be allowed and also, no positive cases have been reported in the District of Dadra & Nagar Haveli;

THEREFORE, in view of above and in exercise of the powers conferred under section 133 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby revoke the Orders dtd. 08/01/2021 and dtd. 11/01/2021, referred in preamble (1) and (2), respectively.
