Sealed Quotations are hereby invited on behalf of the Dr. APJ Abdul Kalam Govt. College, Dadra & Nagar Haveli Uchha Sikshya Samiti, Silvassa for procurement of cloud server space for existing College Website and Web Hosting Service as per Annexure A attached herewith.

TERMS AND CONDITIONS

1. Rates should be inclusive of all taxes and FOR at Dr. APJ Abdul Kalam Govt. College, Silvassa including installation.
2. Rates should be quoted by the firms who are able to provide service & materials from licensed outlets on receipt of the clear supply order and having registered office/ Branch Office in DNH District.
3. Tender duly completed in all respects should be accompanied by Demand Draft or Banker's Cheque for Rs.6500/- (Rupees Six Thousand Five Hundred only) as Earnest Money Deposit in favour of the "Dr. APJ Abdul Kalam Govt. College" payable at Silvassa. The EMD submitted in any form other than mentioned above will not be accepted. Tender received without EMD will be summarily rejected.
4. The Quotation should reach to the office of the undersigned on or before 15.05.2021 upto 2.00 pm. Tender received after due date and time shall not be entertained.
5. Sealed envelope should be super-scribed word "Quotation for procurement of cloud server space for existing College Website and Web Hosting Service".
6. Inferior quality of service and/ or materials, defective or damaged or otherwise, shall be out-rightly rejected. The firms shall replace the same, failing which payment may be withheld and made after full satisfaction of the representative of the college.
7. This is the only Quotation Notice. The supplier should quote rates, as per Annexure-A attached herewith the notice, on their own letter heads OR on plain paper duly rubber stamped.
8. The Contract will be valid for 01 year initially from the date of Order and extendable further, if need be maximum upto two years only.
9. Hosting server must be in India.
10. Hosting must be accessible to the public in fast and secure manner on 24 x 7 bases.
11. Must have Disaster Recovery Centre, has a 'Disaster Recovery Centre (DRC)' set up at a geographically remote location and the website is switched over to the DRC with minimum delay and restored on the Web.
12. Web Hosting Service Provider MUST provide helpdesk and technical support to the department on 24 x 7 x 365 basic
13. Responsible for managing the Cloud service offering throughout
14. Must be the vendor or service provider for any Government Organization and Department Dadra and Nagar Haveli and Daman and Diu (Should provide Document for the same for verification)
15. The successful bidder will have to submit Performance Security Deposit @ 10% of gross bid amount in form of DD or FDR from scheduled bank in favour of "Dr. APJ Abdul Kalam Govt. College", payable at Silvassa.
16. Right to accept or reject or modify specifications (if urgent required as per requirement of IT Dept) is reserved with the undersigned without assigning any reason.
