ORDER

WHEREAS, by the Dadra and Nagar Haveli Extraordinary Gazette no. XXV dated 06/05/2010, “The Right of Children to Free and Compulsory Education Act, 2009” (35 of 2009), (hereinafter called ‘the Act’), Amendment Act, 2012, (30 of 2012), were notified.

WHEREAS, section 3 provides that “every child of the age of six of fourteen years shall have a right to free and compulsory education in a neighbourhood school till completion of elementary education, and)

WHEREAS, section 12(1) (c) of the Act provides that “schools specified in sub clauses (iii) and (v) of clause (n) of section 2 shall admit in class I to the extent of at least twenty five percent of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion.”

WHEREAS, by the Notification No. DE/DNH/RTE-ACT-2009/2017/4301/2018 dated 19/06/2008 published in the Dadra and Nagar Haveli Gazette, extended the Right of Children to Free and Compulsory Education Act 2010, in Union Territory Administration of Dadra and Nagar Haveli , called as the Dadra and Nagar Haveli Right of Children to Free and Compulsory Education (Manner of admission of Minimum 25% children in class I or Pre-school at the entry level for the children belonging to disadvantaged group and weaker section) Rules 2017.;

WHEREAS, by Advertisement, no. DOE/DD/RTE/25% Admissions/2021-22/1783 dated 15/03/2021, the public at large were informed that all the recognized Private Schools in the District of Dadra and Nagar Haveli, will have to provide free and compulsory elementary education to 25 % of the strength of the class to the children belonging to economically Weaker Section and Disadvantaged Group, starting from class I and to submit the duty filled in application forms.
