DECLARATION

WHEREAS, vide Preliminary Notification No. LAQ/Horizontal Curve/Road/PWD-II/31/2020/332/2020 dated 10.12.2020, it was Notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the Improvement of Horizontal Curve on Silvassa-Naroli road between Ch. 7/8 to 8/0 near village Dhapsa.

WHEREAS, as required under sub section (2) of section 15 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, 04 objection were received by the Department, and a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu to proceed with the acquisition process and the same has been approved by the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu.

WHEREAS, the Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu is satisfied, on the basis of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the Rehabilitation and Resettlement Scheme shall be applicable because there are 06 families getting affected due to the proposed acquisition process.

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said lands are required for the public purpose, namely for Improvement of Horizontal Curve on Silvassa-Naroli road between Ch. 7/8 to 8/0 near village Dhapsa.

The Lands Statement and Plan can be inspected in the Office of the Collector, Dadra and Nagar Haveli, Silvassa during the Office hours.


