Ukhrul, the 10th of March, 2019

NO.12/11/MCC/DEO/UKL/LSE-2019: In pursuance of the ECI's Instructions on Restrictions on printing of pamphlets, posters etc. , (ECI's Instruction no.3/9/(ES008)94-JS II/5196 Dt 2/9/94 No.3/9/2004/JS-II Dated 24/8/2004 and No.3/9/2007/JS II Dated 16/10/2007 and Section 127 A of RP Act,1951), it is hereby notified the undernoted instructions for information and compliance to all the concerned and the Printing Press(es) in Ukhrul and Kamjong District:

1. Printers and Publishers are required to comply with the provisions of Section 127 A of RP Act,1951 and ECI's Direction, wherein it is stated that all the Printing Presses shall be informed within 3 days of announcement of Election Program in writing by the District Magistrate to furnish information and printed material as required under Section 127 A of RP Act, 1951.
2. In case of any violation of the provisions of Section 77(1) and 127A of RP Act,1951, 171 H of IPC and Commission's direction, strict action should be taken.
3. Display of Election materials, viz., cardboard badges, paper caps, mobile stickers, sticker badges, Flag banners, Cut-outs, Caps, Masks, Scarf are not under the provisions of Section 127A of RP Act 1951. Therefore, such materials should not be seized for violation under section 127A of RP Act, 1951.

Provisions under Section 127A of Representation of People Act, 1951 requires that:

1. Any Election pamphlets/poster shall bear the name and Addresses of the Printer and published in the print line.
2. One copy of the Declaration as to the identity of the publisher together with a copy of document should be sent to Chief Electoral Officer, Manipur, (If it is situated in the state Capital), or to the District Magistrate, in which it is printed.

Any act of failure to comply with the above instructions and Directives, amounts to an Electoral Offence under Section 127 A of RP,1951 and the Defaulter(s) shall face imprisonment up to 6 (six) months or fine up to 2000/- or both.
