**No. DC(UKL)COVID19/2020:** Whereas, it has been reported that four new persons have been tested COVID-19 positive, and in view of the impending threat of the pandemic in the area, it has become expedient to issue containment measure to prevent spread of the disease in the area;

Now, therefore, **I, Joseph Pauline Kamson, IAS** District Magistrate, Ukhrul District, Manipur in exercise of the powers conferred upon me under Para 12 of "The Manipur Epidemic Diseases, COVID-19 Regulations, 2020" do hereby declare the following containment measures in the geographical areas mentioned in the schedule below with immediate effect:-


1. Sealing of the geographical area.
2. Barring Entry and Exit of population from the containment area.
3. Closure of school and public gatherings.
4. Banning of vehicular movement in the area mentioned below.
5. Initiating active surveillance of COVID-19 cases.

**SCHEDULE**

1. **Whole Campus of Guest House, Hamleikhong.**
2. **Whole of DC's Office, Mini-Secretariat, Eastern Block, except State Bank of India.**
3. **Whole office of LM & Ukhrul Sub-Divisions, Mini-Secretariat, Northern Block.**
4. **Camp office of Chingai Sub-Division, Hamleikhong.**
5. **Camp office of Jessami Sub-Division, Hamleikhong.**

Any person/Institution/Organization found violating any of these measures shall be deemed to have committed an offence punishable under Section 188 of Indian Penal Code and Section 51 of the Disaster Management Act, 2005.
