PROHIBITORY ORDERS UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Ukhrul, the 19th April, 2021

No. 7/88/2019-DM/UKL: In supersession of all previous orders issued in this regard and in pursuance of Home Department's Order No. H-1601/6/2020-HD-HD dated 18-04-2021 in the wake of the rapid increase of COVID-19 cases and whereas, there is likelihood of the outbreak in the District;

Now, therefore, **I, Joseph Pauline Kamson, IAS**, District Magistrate, Ukhrul, Manipur in exercise of the powers conferred upon me under Sub-Section 2 of Section 144, Cr. P.C., 1973, do hereby orders imposition of **NIGHT CURFEW with immediate effect from 7:00 PM to 5:00 AM every day in The Whole of Ukhrul District, Manipur and will remain in force till 30-04-2021** or until further orders whichever is earlier. Any persons found in violation of the prohibitory order is liable to be punished under Section 188 of IPC.

The curfew imposed shall not be applicable to the categories listed below and shall be allowed free movement:

- i. All goods carrier vehicles including medical oxygen.
- ii. All essential service establishments like pharmacies, Clinics, Hospitals, Power supply, Public Health Engineering, UADC engaged in cleaning and Fire Services.
- iii. Media persons and all Telecom Services and time bound project constructions.
- iv. All gatherings are banned with immediate effect except unavoidable gatherings for funerals, marriages, time-bound religious rituals/ceremonies. Such gathering will also be strictly limited to 20 persons, covid appropriate behaviours, including wearing of face mask, is to be ensured by the host/organizer. Violators are to be penalized promptly.
- v. All shops and markets to ensure wearing of face masks and take steps to prevent crowding in their shops, market areas.
- vi. Crowding in tourist spots, historical sites etc, are to be prevented by the department or agency concerned.
- vii. All personnel of the establishments mentioned at ii above including that of Veterinary services
- viii. All government officials who have been assigned specific duties of covid-19 management or other emergency services.

This order is directed to the public in general and as the circumstances do not permit serving of a notice in due time upon the person(s) against whom the order is directed, this order is passed-ex-parte.
