ORDERS UNDER SECTION 144-OF THE CODE OF CRIMINAL PROCEDURE
Ukhrul, the 7th September, 2021

No. DC(UKL)COVID19/2020: Whereas, the Chairperson, State Executive Committee has issued Orders under section 20(2)(a) of the Disaster Management Act, 2005 vide Order No. H-1601/6/2020-HD-HD dated 6th September, 2021 extending **Night Curfew from 7 P.M. to 4 A.M. for 15 days w.e.f. 7-09-2021 to 21-09-2021**, and unlocking the following activities listed below.

Now, therefore, **I, Joseph Pauline Kamson, IAS**, District Magistrate, Ukhrul, Manipur in exercise of the powers conferred upon me under Sub-Section 2 of Section 144, Cr. P.C., 1973, do hereby prohibit the movement of any person outside their respective residence **from 7 P.M. to 4 A.M. w.e.f. 7-09-2021 to 21-09-2021 in the whole of Ukhrul District, Manipur.**

List of permitted activities:

1. All Offices in the District are to function normally.
2. All **Standalone shops** in the District are permitted to open from **7:00 AM to 5:00 PM every day except Sunday** with strict observation of SOP.
3. Hotels for lodging will be allowed to remain open with minimum staff.
4. NREGS Activities, NHIDCL projects, NDB projects of PHED, PMGSY and other important projects of the government.
5. Bank services **may function normally from 10:00 AM to 2:30 PM** on all working days by taking adequate precaution and strictly following Covid Appropriate Behaviour.
6. And other activities permitted by the State government which are applicable in our District.
7. Health Department shall scale up vaccination, contact tracing and testing by providing additional man power, mobility support and IEC-Advocacy.
8. **SOCIAL GATHERINGS /FEASTS are not permitted.**

During this Night Curfew, Sub-Divisional Magistrates as Incident Commanders, along with District Police Officers, will ensure that the above orders is strictly enforced.
