Sealed quotations/tenders are invited from interested reputed Travel Agencies/Service Provider for providing 01 (one) no of Non AC Diesel/Petrol driven vehicles (TUV300/Bolero/Sumo Gold/Ertiga) having sitting capacity not more than ten including driver, which shall conform to the Terms and conditions (Annexure - II) for use in Office of the CDPO on monthly rent basis in respect of ICDS Kirmira within the rate Rs.20, 833/- (Rupees twenty thousand eight hundred thirty three) only. The undersign reserve the right to cancel for all tender without assigning any reason.

- 1) The vehicle be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the CDPO Kirmira, Payable at SBI Kirmira and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charges be quoted separately in the general bid information (excluding fuel and lubricants)
- 6) The Vehicle must achieve a fuel efficiency of 10 Kms per litre.
- 7) The details of the make and year of manufacture of the vehicle. Registration no., mileage (Kms covered per litre) and name of the Driver with Driving License No. And period of validity should be specifically provide in the general bid information to be furnished with the Quotation/Tender (Annexure - III)
- 8) The Quotation completed in all respect should reach the undersigned on or before 21.01.2021 by 1.30 PM. Bidders are requested to put their tender paper in the tender box of this office and shall be opened on the same day at 2.30 PM in presence of the bidders or their authorized representatives.
