Term and Condition:

1. The rate to be quoted should be inclusive of all taxes and transportation charge.
2. Xerox copies of Up to date tax clearance certificate, valid registration certificate of the firm and PAN card must be submitted alongwith the tender papers. The original ones must be produced on the date of opening of the tenders for verification by the purchase committee
3. The sealed tender with superscribing on the top of envelop as **TENDER FOR SUPPLY OF MATERIALS** should reach the office of the Child Development Project Officer, Chandahandi through **SPEED/REGISTRED post/ by hand** on or before **26.02.2019 by 5.00 P.M.** The undersigned is not responsible for any postal delay.
4. The tenders will be opened on Dt. **27.02.2019** at **.3.00 P.M.** in presence of the bidders or any of their representatives in the **Office chamber of the Sub-Collector, Nabarangpur.**
5. Samples of each materials as per the specification must be produced before the Purchase committee on the day of opening of tenders for selection of the materials , failing which the tender shall not be entertained.
6. The successful bidder shall deposit @5% of the total cost of the material towards Security deposit ( refundable without interest) in shape of Demand Draft in favour of the Child Development Project Officer, Chandahandi drawn in any nationalised/ scheduled bank payable at SBI, Umerkote.
7. The quantity of the articles is tentative and may be changed depending




upon availability of funds.

7. The successful tenderer shall deliver the materials at the ICDS office, Chandahandi within 15 days from the date of issue of supply order, failing which the order shall be automatically cancelled and no further time will be allowed for supply.

8. Any damaged materials and the materials not as per the specification found at the time of delivery of the materials must be replaced immediately with own cost of the supplier.

9. The payment will be made by the undersigned after supply of the materials in full.

10. The undersigned reserves the rights to cancel or reject any/all the tenders without assigning any reasons thereof.






