Item No.01

Heard. This is an application for fresh inter district regular permit in respect of stage carriage KL-15-6408 to operate on the route Vadakkumpuram-Aluva via North Parur, Naluvazhy, Mannam, Kottappuram and U.C. College as Ordinary Service. The STU is the applicant. The proposed route reserved exclusively reserved for the State Transport Undertaking. Hence fresh regular permit granted with proposed set of timings.

Item No.02

Heard. This is an application for fresh inter district regular permit in respect of stage carriage KL-15-6412 to operate on the route Vadakkumpuram-Aluva via North Parur, Naluvazhy, Mannam, Kottappuram and U.C. College as Ordinary Service. The STU is the applicant. The proposed route reserved exclusively reserved for the State Transport Undertaking. Hence fresh regular permit granted with proposed set of timings.

Item No.03

Heard. This is an application for fresh inter district regular permit in respect of stage carriage KL-15-7781 to operate on the route Vadakkumpuram-Aluva via North Parur as Ordinary Service. The STU is the applicant. The proposed route reserved exclusively reserved for the State Transport Undertaking. Hence fresh regular permit granted with proposed set of timings.

1.Perused the judgment of Hon'ble High Court of Kerala in WP© No.15448 of 2014 dtd 25/06/2014.

2. Heard the learned Counsel Adv. P. Deepak represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL-07-AQ-3040 or suitable stage carriage to operate on the route Thammanimattom-Kolencherry-Kakkanad-Co-Operative medical College-Trippunithura and Maradu Market as Ordinary moffusil service. This authority in its earlier sitting dtd 06/01/2014 vide item No.19 considered the application and rejected on the grounds that the applicant was failed to produce suitable stage carriage. Thereafter the applicant has offered stage carriage KL-07-AQ-3040 with seating capacity 33 in all and produced a copy of the judgment of Hon'ble High Court of Kerala in WP© No.15448 of 2014 wherein earlier order of this authority dtd 06/01/2014 was set aside and directed to reconsider the application afresh within a time limit. In view of the above order, this authority considered the application in detail. The proposed route having length of 34.7 km in which 9.9 km lying under the jurisdiction of RTA, Muvattupuzha. The applicant has not provided sufficient trips to ill served places on the proposed route such as Kaninadu, Thammanimattom and Medical College. The Regional Transport Authority is constituted for consideration of application for the grant of permit on interest of public. But in this case the applicant proposed trips and timings so as to focus operation between well served areas such as Kolencherry, Karimugal and HMT. Hence the proposal is not convenient to the travelling public of ill served areas. Hence the applicant is directed to submit a modified proposal by providing more trips to ill served areas such as Thammanimattom, Kaninadu and Medical College. Hence adjourned.

Item No.05

1. Perused the judgment of Hon'ble High Court of Kerala in WP© No. 10351 of 2014 dtd 21/05/2014.

2.Heard the learned Counsel Adv.G.Prabhakaran represented the applicant. This is an application for the grant of fresh regular permit in respect of Suitable stage carriage to operate on the route HMT Jn-Infopark Main Gate as Ordinary moffusil service. This authority in its earlier sitting dtd 06/01/2014 vide item No.09 considered the application and rejected on the grounds that the applicant was failed to produce suitable stage carriage and the focus of operation in the major trips between Trippunithura and Kakkanad amounts to classification of city service. Thereafter the applicant has produced a copy of the judgment of Hon'ble High Court of Kerala in WP© No.10351 of 2014 wherein earlier order of this authority dtd 06/01/2014 was set aside and directed to reconsider the application afresh within a time limit.

In view of the above order, this authority considered the application in detail. The proposed route having length of 43.5 km in which 15 km lying under the jurisdiction of RTA, Muvattupuzha. The enquiry officer has reported that no sufficient stage carriages are operating on the portions of the proposed route from Kakkanad to HMT jn and from Kakkanad to Infopark Main Gate. Secretary, RTA will obtain concurrence of RTA, Muvattupuzha and place in next RTA. Hence adjourned.

Item No.06

Heard the learned counsel Adv.G.Prabhakaran represented the applicant. This is an application for the grant of fresh regular permit to operate on the route Ernakulam High Court Jn-North Parur as ordinary moffusil service in the vacant timings of stage carriage KL-23-E-3831. The applicant has offered stage carriage KL-07-AC-3989.The learned Counsel Adv.P.Deepak represented other stage carriage operators on the sector has objected the grant of permit stating that the full set of timings of stage carriage KL-23-E-3831 are not vacant as stated by the counsel represented the applicant. He has also alleged that the applied route portion is fully saturated and introduction of further stage carriage services will invite unhealthy competition, which may result in road accidents. Hence Secretary RTA will collect a feasibility report from the executive engineer PWD Roads division, Ernakulam for the introduction of further stage carriage services on the sector without making any chance for ill health of other road users such as pedestrians, Cyclists etc. Moreover the enquiry officer has reported that the proposed route is overlapping Aluva-Kuriappilly complete exclusion scheme. But the report is not specific for ascertaining whether the overlapping is objectionable or not. Hence Secretary, RTA is directed to obtain a specific report from the field officer. The report should contain the statistics of existing stage carriage services. Hence adjourned.

Item No.07

Heard the learned counsel Adv. Jithesh Menon represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage to operate on the route Koonammavu-North Parur-High Court Jn via Cheriappilly, Chettibhagam, Varappuzha Bridge, Container Road and Gosree Bridges. The route is having length of 27 km in which 3.4 km overlapping on Aluva-Chathanad complete exclusion scheme with exceptional clause. The applied route does not violate the conditions prescribed in Government Notification No.655/TA4/60/PW dtd 28/08/1961. Hence a regular permit is granted to a suitable stage carriage offered by the applicant, on the route Koonammavu-North Parur, subject to settlement of timings.

Heard the learned counsel Adv. Jithesh Menon represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage to operate on the route High Court Jn-North Parur as ordinary moffusil Service. The applicant has not offered a registered vehicle even at the date of meeting of this authority. The route is having length of 27 km in which 3.4 km overlapping on Aluva-Chathanad complete exclusion scheme with exceptional clause. The applied route does not violate the conditions prescribed in Government Notification No.655/TA4/60/PW dtd 28/08/1961. Hence a regular permit is granted to a suitable stage carriage offered by the applicant, on the route Koonammavu-North Parur, subject to settlement of timings.

Item No.09

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage to operate on the route Pattimattam-Trippunithura-Medical College via Pancode, Vadavucode, Kavumthazham, Karthedathpady, Pannikkuzhy, Chalikkara, Ku zhikkad, Hill Palace, Trippunithura, Eroor, Vennala and Vyttila as ordinary moffusil Service. This authority considered the application in detail. The applicant has proposed above route stating that the major portions of the routes such as Kavumthazham, Karthedathupady, Pannikkuzhy, Chalikkara and etc.But as per trip and time schedule proposed by the applicant it is clear that he has not provided sufficient trips to the ill served Kavumthazham, Pannukkuzhy and Chalikkara. In the same time he provided more trips so as to operate between Trippunithura and Vyttila Hub which is a well served sector coming under Kochi City Limits. The Regional Transport Authority is constituted for consideration of application for the grant of permit on interest of public. But in this case the applicant proposed trips and timings so as to focus operation between well served areas such as Trippunithura and Vyttila. Hence the proposal is not convenient to the travelling public of ill served areas. Hence the applicant is directed to submit a modified proposal by providing all trips from Trippunithura upto Pattimattam via above mentioned ill served areas without focusing the operation between Vyttila and Trippunithura which amounts to City Service. Hence adjourned.

Item No.10

Heard the learned counsel Adv.Stalin Peter Davis represented the applicant. This is an application for the grant of reserve stage carriage permit in respect of stage carriage KL-07-AG-8269 with seating capacity 48 in all or a suitable vehicleto operate in places of following stage carriages having valid regular permits issued by this authority.

This authority considered the application in detail. The applicant is eligible for to maintain a spare bus and to obtain reserve stage carriage permit Under Rule 182 of KMV Rules 1989. The offered vehicle was registered during the year 2002. Hence reserve stage carriage permit is granted in respect of stage carriage KL-07-AG-8269 or a suitable vehicle to operate in places of above mentioned stage carriages subject to the compliance of conditions attached under SRO No.880/75 published vide notification No.33942/TC2/75-9/PW dtd 29/09/1975.

Item No.11

Heard the learned counsel Adv.Jithesh Menon represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage to operate on the route High Court Jn-North Parur via Container Road, Mulavukad, Cheranelloore, Varappuzha Bridge, Koonammavu, Kalamassery Bridge and HMT as Ordinary Moffusil Service. The applicant has not offered a registered vehicle even at the date of meeting of this authority. The route having length of 36.1 km in which 1.8 km overlapping on Aluva-Chathanad complete exclusion scheme and a distance of 800 metre overlapping on Trivandrum-Kannur and Ernakulam-Thrissur notified scheme published vide GO(P) No.42/2009/Tran dtd 14/07/2009. The report of enquiry officer is not specific for ascertaining whether the overlapping on Aluva-Chathanad scheme is objectionable or not. Secretary, RTA is directed to obtain a detailed and specific report in this regard. Hence adjourned.

Item No.12

Heard the learned counsel Adv.Gopinathan Nair represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage with seating capacity not less than 28 in all to operate on the route Adivaram-Desom Jn as Ordinary Moffusil Service. This authority considered the application in detail. The applicant has not offered details of registered stage carriage even at the sitting of this authority. The time schedule proposed by the applicant contain 10 trips in which he has provided only 3 trips to Desom which is

one of the termini of the proposed route. The Regional Transport Authority is constituted for consideration of application for the grant of permit on interest of public. In this case terminus Desom is ill served and hence the avoiding of trips to that place is against the interest of the public. Hence the applicant is directed to submit a modified proposal by providing all trips to Desom an ill served area. Secretary, RTA is also directed to report the feasibility of the new proposal. Hence adjourned.

Item No.13

1.Perused the judgment of Hon'ble STAT in MVAA No.286/2013 dtd 30/04/2014 wherein this authority is directed to consider the application for the grant of variation of permit in accordance with law.

2. Heard the learned counsel Adv. Jithesh Menon represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-07-AU-786 permitted to operate on the route North Parur-Kaloor via Varappuzha Bridge, Edappally, Elamakkara and Punnakkal as Ordinary Moffusil Service. This authority considered the application in detail. The proposed variation includes curtailment of trip from North Parur to Kaloor and extension of service from Koonammavu to North Parur. This authority is convinced that the curtailment of service especially the night trip will deprive the existing benefits enjoyed by the travelling public. It is against the public interest. Hence the curtailment cannot be allowed. Vide reported decision in Krishnan v. RTA, 1991(2) KLT 302 it is clarified that the applicant has to satisfy the transport authority about the public convenience as the ground of extension. In this case the applicant is failed to convince this authority about the public convenience consequent to the proposed extension. There is no necessity Under Rule 145(6) of KMV Rules 1989 warranting the proposed variation. Moreover the portion of the proposed route from North Parur to Thekkenaluvazhy which is 1.5km in length objectionably overlaps Aluva-Vadakkumpuram complete exclusion scheme which is exclusively reserved for the State Transport Undertaking. If the proposed deviation granted, it will be a clear violation of the scheme of nationalization. In the above circumstances the application for variation of permit is hereby rejected.

Item No.14

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-16-804 permitted to operate on the route Infopark Phase-II-Karimugal as ordinary service. This authority considered the application in detail. Consequent to the proposed deviation there is a curtailment of trips from Infopark to Trippunithura via Padathikkara and Karimugal. The Regional Transport Authority is constituted for considering the applications on public interest. The enquiry officer has not reported the effect of curtailment of existing service. Secretary, RTA is directed to obtain a detailed report in this regard. Hence adjourned.

1.Perused the judgment of Hon'ble STAT in MVAA No.147/2013 dtd 31/05/2014 wherein this authority is directed to consider the application for the grant of variation of permit in accordance with law.

2. Heard the learned counsel Adv. G. Prabhakaran represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-07-AV-910 permitted to operate on the route Fort kochi-Kallancherry Church as Ordinary Moffusil Service. This authority considered the application in detail. The proposed variation includes curtailment and deviation. This authority is convinced that the curtailment of service of service from Kumbalangy Vazhy to Kumbalangy and to Kallancherry Church will deprive the existing benefits enjoyed by the travelling public. During the year 2003 this authority granted regular permit on the route Fort Kochi-Kallancherry for the convenience of the travelling public especially of the Kallancherry area. After a gap of eleven years, the permit holder has applied for curtailment of service stating that the width of the road is not sufficient to operate service. Vide judgment in MVAA No.147/2013, the Hon'ble STAT has directed this authority that if even a 23 seater stage carriage cannot conveniently and safely ply through the proposed curtailment portion, the proposed curtailment will have to be allowed. The enquiry officer has reported that stage carriage with seating capacity can be operated between Gramapanchayath Jn and Kallancherry Church .The Kumbalangy Gramapanchayath also filed objection against the curtailment of trips to Kumbalangy. The proposal for curtailment is against the public interest. Hence it cannot be allowed. Vide reported decision in Krishnan v. RTA,1991(2) KLT 302 it is clarified that the applicant has to satisfy the transport authority about the public convenience, the ground of extension. In this case the applicant is failed to convince this authority about the public convenience consequent to the proposed variation. There is no necessity Under Rule 145(6) of KMV Rules 1989 warranting for the proposed variation. Hence the application for variation of permit is hereby rejected.

Item No.16

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-40-B-1410 permitted operate on the route Chottanikkara-Aluva Thiruvankulam, Tripunithura, Vyttila, South, High Court, Edappally and Kalamassery as Ordinary City Service. This authority considered the application in detail. The proposed variation includes curtailment and deviation. This authority is convinced that the deviation of 2nd trip from Edappally Signal Jn to Vyttila via Bypass by curtailing trip via Ernakulam South and High Court will deprive the existing benefits enjoyed by the travelling public to reach Kochi City. Hence the proposal for curtailment of 2nd trip is against the public interest. Hence the curtailment cannot be allowed. Vide reported decision in Krishnan v. RTA,1991(2) KLT 302 it is clarified that the applicant has to satisfy the transport authority about the public convenience as the ground of variation. The proposed deviation portion is well served and sufficient stage carriages are operating to cater the need of the public.

In this case the applicant failed to convince this authority about the public convenience consequent to the proposed deviation. On comparing of the proposed time schedule with existing one it is clear that the intention of the applicant is only to alter the existing time schedule for his convenience. There is no necessity Under Rule 145(6) and 145(7) of KMV Rules 1989 warranting the proposed variation and revision of existing timings. Hence the application for variation of permit is hereby rejected.

Item No.17

Heard the learned counsel Adv.G.Prabhakaran represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-11-Q-1549 permitted to operate on the route Kumbalangy Ferry-Kakkanad as ordinary service. This authority considered the application in detail. The proposed variation includes curtailment of trips from Palarivattom to Kakkanad and extension of service to Kunnumpuram. On perusal of the records it is revealed that the applicant had availed a variation of permit during the year 2008 by extending the service up to Kakkanad. But the agenda and notes do not specify the earlier variation availed. The report of the field officer is also not specific to ascertain whether the proposed extension violates the Section 80[3] of MV Act or not. The Secretary,RTA is directed to obtain a detailed report in this regard and to furnish a detailed report in next RTA. Hence adjourned.

Item No.18

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-07-AF-1744 permitted to operate on the route Aluva-Edayar Bus Stand via Pathalam, Industrial Jn, Muppathadam East West Kodungalloor, Thottakkattukara Jn, Aluva Bypass Jn as ordinary moffusil service. This authority considered the application in detail. The proposed variation includes extension, deviation and curtailment. The enquiry officer has reported that the curtailed portion is well served than the deviation portion. Hence the proposed variation is highly beneficial to the travelling public and students of Kaiyindikkara-Ellokkara sector. The extension of trip to Pathalam is also beneficial to the public. The Regional Transport Authority is constituted for consideration of application for the grant of permit on interest of public. In this case there exist public interest. Hence the proposed variation is allowed subject to settlement of timings.

Item No.19

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-40-2419 permitted to operate on the route Poothotta-Aluva via Trippunithura, Vyttila, South, Jetty, Kaloor, Palarivattom and Kalamassery as ordinary service. The proposed variation includes deviation, Curtailment and additional trips. This authority considered the matter in detail. The existing time schedule contains 6 trips. The applicant has proposed variation so as to deviate 2nd trip via Edappally Bypass and to provide additional trips between Trippunithura and High Court via Enakulam South. Hence the trips will be enhanced to ten in number. The proposed variation

includes additional trips to Medical College, which is compatively ill served. Hence it is beneficial to travelling public. While considering the application by this RTA on variation the prime consideration is the advantages offered to the public. Hence variation granted as applied for subject to settlement of timings.

Item No.20

Heard the learned counsel Adv.G.Prabhakaran represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-07-BC-2512 permitted operate route on the Poothotta-Aluva Tripunithura, Menaka, Kaloor, Palarivattom, Edappally and Kalamassery as Ordinary City Service. This authority considered the application in detail. The proposed variation includes curtailment and deviation. This authority is convinced that the deviation of 2nd, 4th and 6th trip from Edappally Signal Jn to Vyttila Signal Jn via Bypass by curtailing trip via Ernakulam South will deprive the existing benefits enjoyed by the travelling public to reach Kochi City. The proposal for curtailment of above trips is against the public interest and hence it cannot be allowed. Vide reported decision in Krishnan v. RTA,1991(2) KLT 302 it is clarified that the applicant has to satisfy the transport authority about the public convenience as the ground of variation. The proposed deviation portion is well served and sufficient stage carriages are operating to cater the need of the public. In this case the applicant is failed to convince this authority about the public convenience consequent to the proposed deviation. On comparing with the proposed time schedule with existing one it is clear that the intention of the applicant is only to alter the existing time schedule for his convenience. There is no necessity Under Rule 145(6) and 145(7) of KMV Rules 1989 warranting the proposed variation. Hence the application for variation of permit is hereby rejected.

Item No.21

Heard the learned counsel Adv. Jithesh Menon represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-42-A-3060 permitted to operate on the route Kothad Ferry-Kundannur via Ponekkara, Jetty as Ordinary City Service. This authority considered the application in detail. The proposed variation includes extension only .By the proposed variation ,the permit holder is intended to revise the timings of major trips. So many objections have been received against the proposed timings. The elimination of settled position of timings will adversely affect the travelling public and other enroute operators. Hence it cannot be allowed. Hence the applicant is directed to submit a modified time schedule without disturbing the timings of other operators on the sector. Moreover the enquiry officer has not reported the necessity under rule 145[6] of KMV Rules for the proposed variation. Secretary, RTA is directed to obtain a detailed report and place the matter in the next sitting of this authority. Hence adjourned.

Item No.22

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-07-BD-3535 permitted to operate on the route Thuthiyoor-Thevara Ferry via Menaka, Palarivattom, Kakkanad and CSEZ as Ordinary City Service. This authority

considered the application in detail. The proposed variation includes curtailment, deviation and extension. Considering the benefits and disadvantages expected by the addition and curtailment respectively, in total, the variation is more beneficial to general public and hence allowed subject to settlement of timings.

Item No.23

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL-40-4244 permitted to operate on the route Palamkadavu-Puthukkalavattom via Chembu, Poothotta, Trippunithurta, Vyttila, Jetty and Kaloor as Ordinary City Service. The proposed variation includes extension, deviation and curtailment of trips between Kaloor and Puthukkalavattom and between Poothotta and Palamkadavu and between High Court and Kaloor. This authority considered the application in detail. The proposed variation includes a service through virgin portion which is highly beneficial to public. Considering the advantages expected by the proposed addition and disadvantages expected by the proposed curtailment, the proposed variation in toto will be beneficial to general public and hence allowed subject to settlement of timings.

Item No.24

Heard the learned counsel Adv.Stalin Peter Davis represented the applicant. This is an application for replacement of stage carriage KL-08-AJ-2500[2006 model] covered by a regular permit on the route Vettilappara Block No.13-Angamaly valid up to 17/02/2016. The regular permit is kept under suspended animation in compliance to the judgment of Hon'ble High Court of Kerala. Hence extension of time for four months in aggregate Under Rule 159(2) of KMV Rules 1989 is allowed.

Item No.92

Perused the decision of the State Transport Authority held on 27/05/2014[Item No.21]. In view of the above decision this authority will act in accordance to the STA direction in future.

Item No.93

Perused the connected files. This is a representation for renovation of the Bus Shelter at Parakkadavu Jn, Angamaly. A detailed enquiry has been conducted through the field officer and he has reported that the proposal is beneficial to the travelling public and recommended the proposal for renovation. Hence renovation of bus shelter at Parakkadavu is allowed by providing bus way without causing traffic congestion in that place subject to the approval of PWD authority.

Item No.94

Heard the representatives of KSRTC and learned counsel represented the private stage carriages. This is a request for fixation of fare stage at Kudikilan Kavala in between Malayattoor and Illithode on the route Kalady-Mulamkuzhy via Malayattoor, Kadappara and Illithode. Perused the connected files, enquiry report furnished by the field officer. KSRTC, Angamaly has intimated that consequent to the elimination of one fare stage at Kadappada on the route Kalady-Adivaram, the point Kadappada which was one of the fare stage on the route Kalady-Mulamkuzhy is also eliminated. Due the above elimination there is a distance of 5 kms between the two stages[Malayattoor and Illithode] on the route Kalady-Mulamkuzhy and it is adversely affect the service of State Transport Undertaking. A detailed enquiry has been conducted through the Joint Regional Transport Officer, Angamaly and he has reported that the request filed by the KSRTC is genuine and recommended to fix Kudikkilankavala which is 2.1 km from Malayattoor as a fare stage on the route Kalady-Mulamkuzhy.In these circumstances this authority hereby decides to fix Kudikilankavala as a fare stage on the route Kalady -Mulamkuzhy via Malayattoor, Kadappara and Illithode as per Rule 211 of KMV Rules 1989.

Heard.Perused the connected files. This is a request for announcing the portion from Ernakulam-Medical Centre to Puthiya Road Jn on N.H Byepass as a "No Parking Zone" and to accord sanction for fixation of No Parking Sign Boards on that portion. This authority considered the representation filed by Vennala Shobha Road Residents Association and enquiry report furnished by the field officer in this regard. The enquiry officer has reported that the unauthorized parking of vehicles on the proposed area is making obstruction to the free movements of the vehicles

Perumpadappu was expired on 14/07/2014. Thereafter the permit holder has applied for the renewal of permit. Hence there is no vacancy of stage carriage exist. This authority considered the scope and applicability of the grant of permit on the proposed route. The proposed route having length of 31 kms in which the portion from Kumbalangy Vazhy to Aluva which is 30 km in length objectionably overlaps Trivandrum-Kannur and Trivandrum-Palakkad notified scheme published vide GO(P) No.42/2009/Tran dtd 14/07/2009. As per clause 5(c) of the above said notification, regular or temporary permits can be granted to private stage carriages of other routes permitting them to overlap 5 km or 5% of the length of the route whichever is less on the notified routes for the purpose of intersection. In this case, the total route length is 31 kms and the distance of overlapping is 30 km, which is beyond the permissible limit . This authority is prevented from the grant of permit on a notified scheme violating the scheme of nationalization. Hence the application for the grant of permit is hereby rejected.

2. Heard. The learned Counsel Adv. G. Prabhakaran represented the applicant. The enquiry officer has reported that the proposed service is beneficial to the travelling public and the overlapping on notified scheme is not objectionable. The Regional Transport Authority is constituted for the consideration of application for the grant of permit on interest of public. The applicant was operating service on the same route with a temporary permit issued in compliance to the judgment of Hon'ble High Court of Kerala in WP(c) No.8423/2014 with a set of settled timings. In the light of above facts and circumstances fresh regular permit granted with the existing set of settled timings.

1.Heard the learned Counsel Adv.Gopinathan Nair represented the applicant. This is an application for the grant of counter signature on issued regular permit in respect of stage carriage KL-34-B-1533 to operate on the route Kumily-Vyttila Hub via Vandiperiyar, Mundakkayam, Kottayam, Ettumanoor, Thalayolapparambu, Arayankavu, Mulamthuruthy, Vattukunnu, Kandanad, Kureekad, Trippunithura Byepass, Maradu and Kundannur as Super Fast Service. represented KSRTC has requested to adjourn the matter for detailed Study.RTA,Kottayam had granted the permit as ordered by Hon'ble STAT in MVAA/2011 dtd 16/09/2011 and RTA Kottayam had issued a regular permit subject to counter signature of RTA,Ernakulam,which is valid up to 07/03/2018.The grantee has modified the route portion in the jurisdiction of this authority as ordered by the Hon'ble STAT in MVAA/2011 dtd 16/09/2011,in such a manner that there is only 100 metre overlapping in Ernakulam-Thekkady Scheme,which is within the limits prescribed in Govt.Notification 42/2009/Tran dtd 14/07/2009.Hence objection raised by KSRTC is overruled and Counter signature is granted in the portion lying in the jurisdiction of this authority.

Hence transfer of permit allowed subject to clearance of government dues if any, as applied for.

This is an application for transfer of permit in respect of stage carriage KL-43-B-2554 operating on the route Perumpadappu-Aluva as Ordinary Service .No Check reports are pending against the vehicle. NOC from the financier produced.Hence transfer of permit allowed subject to clearance of government dues if any,as applied for.

Supplementary Item No.10

Heard the learned counsel Adv.Stalin Peter Davis represented both the applicants. This is an application for transfer of permit in respect of stage carriage KL-07-AC-3965 operating on the route Poothotta-Aluva as Ordinary Service .No Check reports are pending against the vehicle. NOC from the financier produced.Hence transfer of permit allowed subject to clearance of government dues if any,as applied for.

Supplementary Item No.11

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for renewal of intra district regular permit on the route Thevakkal-Kumbalam. This authority considered the application in detail. Regular permit issued to stage carriage KL-07-AR-4107 to operate on the route Thevakkal-Kumbalam is kept under suspended animation and the vehicle KL-07-AR-4107 was released from the permit and issued clearance certificate in compliance to the judgment of Hon'ble High Court of Kerala in WP(c) No.22969/2013 dtd 12/09/2013. Subsequently the regular permit expired on 12/06/2014. On 12/06/2014 the permit holder has offered another later model vehicle and applied for renewal of permit and replacement of the vehicle. The applicant has requested for the condonation of delay in filing application for renewal of permit. This authority satisfied with the explanation offered by the permit holder.

This authority felt that the outgoing vehicle is of seating capacity of 27 in all and the proposed later model vehicle having seating capacity 39 in all. The replacement of the vehicle of seating capacity 27 with a later model vehicle with seating capacity will increase the traveling facility of the public and also helps to increase the revenue toward the government. In view of the above facts delay condoned and renewal of permit granted and replacement of the vehicle allowed as applied for.

Supplementary Item No.12

Heard the learned counsel represented the applicant. This is an application for the renewal regular permit in respect of stage carriage KL-04-R-7968 permitted to operate on the route Perumpadappu-Aluva as ordinary moffusil service. The

counsel represented the KSRTC and the counsel represented the private stage carriage operators have requested to adjourn the matter to the next sitting for a detailed perusal. Hence adjourned to next sitting.

Supplementary Item No.13

1&2. Heard the learned counsel Adv. G. Prabhakaran represented the applicant. This is an application for the renewal of regular permit in respect of stage carriage KL-05-AA-8474 operating on the route Kottayam-Perikkalloor as Super Express Service. This authority elaborately considered the application in view of existing law,notification and Judgments. The service is operating as Fast Passenger Service. As per GO(P) No.73/2013/Tran dtd 16/07/2013, the right to operate any class of service other than ordinary service is in the state of Kerala in reserved exclusively for State Transport Undertaking. As per clause(3) of the above notification, the higher class permits such as Fast passenger, Super Fast and Super express etc issued in private sector will be allowed to continue till the expiry of the respective permits. Thereafter no permits shall be renewed .Vide Judgment in WP(c) No.18959/2013 dtd 17/03/2014, the Hon'ble High Court of Kerala has also upheld the above notification. If the permit is renewed as Fast Passenger Service, it will be the clear violation of above notification and connected Judgments. KSRTC vehemently objected the renewal of permit as Fast Passenger stating the existing area scheme, but they have not applied for a new permit on the same route. So in view of the Government Order No.10689/B1/2014/Tran dtd 17/07/2014,the decision is adjourned. Secretary, RTA will issue temporary permit U/S 87(1)d of MV Act on application, for the continuance of service on public interest.

3.This authority considered the application for transfer of permit U/S 82[2] of MV act. There is no valid regular permit in respect of stage carriage KL-04-AA-8474. The vehicle is covered by temporary permit only. There is no provision of law for the transfer of temporary permit. Hence decision is adjourned. The application will be considered at the time of renewal of the permit. The possessor of the vehicle is permitted to operate service with temporary permit issued by the Secretary RTA.

Supplementary Item No.14

Heard the learned counsel Adv.P.Deepak represented the applicant. This is an application for replacement of the stage carriage covered by a regular permit valid up to 29/06/2016 by an older model vehicle KL-07-AG-8269 possessed under lease agreement .This authority considered the application in detail.

This is a case where a later model vehicle(2010 model) covered by a stage carriage permit is sought to be replaced by an older model(2000 model) stage carriage. The regular stage carriage permit was granted in respect of 2010 model vehicle bearing registration No.KL-40-D-9679 to operate service on the route Poothotta-Aluva. The permit so granted is valid from 30/06/2011 up to 29/06/2016. After operating service hardly for three years, the permit holder sold the vehicle to another person. The clearance for the vehicle was granted on a direction of court keeping the permit on suspended animation. Obviously ,the vehicle KL-40-D-9679 was in sound and satisfactory condition for stage carriage

service. There was no reason for the applicant to sell the vehicle and facilitate its operation on different route by another operator, other than selling the same for more attractive considerations. This action of the permit holder caused refusal of stage carriage service on the said route where there is lack of services and the passengers were put on to untold miseries. At the same time, the permit holder wanted to retain the validity of permit so as to substitute a bus irrespective of its age and revive the service on the route Poothotta-Aluva.

Rule 174(2)(d) of KMV Rukes suggest that the authority may reject an application for replacement of vehicle, where the incoming vehicle is older than the outgoing vehicle subject to discretion of power stated there in.

This authority has examined the various circumstances under which a stage carriage fit for operation on a long route was sold out for consideration and an old vehicle sought to be pressed in to the service on such long route to the utter disadvantage to the travelling public. This authority have also examined the merits of the application in the light of the comparison table of the both vehicles furnished by the applicant. It is a case where there exists a material difference of more than 25 % with regard to seating capacity.

The applicant/Permit holder does not appear to be keen in providing traveling facility to the public; on the other hand ,he has engaged in selling and buying the vehicle for profit and to the detriment of public safety and convenience .We have also observed that the object of MV Act 1988 that the safety of public. While comparing two vehicles of 2010 model and 2000 model, the vehicle of 2010 model will be in a better position regarding safety and there is considerable difference.

Having regard to the aforesaid circumstances and exercising the discretionary power under rule 174(2)d, the application for replacement is hereby rejected.

Supplementary Item No.15

Heard the learned counsel Adv.P.Deepak represented both the applicants. This is an application for transfer of permit in respect of stage carriage KL-41-A-8853 operating on the route Aluva-Konthuruthy as Ordinary Service .Check reports or HPA are not pending against the vehicle. Hence transfer of permit allowed subject to clearance of government dues if any, as applied for.

Supplementary Item No.16

Heard the applicant. This is an application for the grant of temporary permit for a duration of 4 months in respect of stage carriage KL-07-AX-3128 to operate on the route Vypin-Gothuruth with extension to Ernakulam High Court Jn in place of stage carriage KL-42-C-7698.Regular permit issued to the route bus KL-42-C-7698 expired on 31/08/2012 and application for renewal is pending. The route bus is defaulted service and the applicant for temporary is operating service with issued temporary permit U/S 87[1]c of MV Act. This authority felt that there exist necessity for the grant of temporary permit on the proposed route. Hence temporary permit for 4 months U/S 87(1)C granted on public interest.
