RULES

S. R. O. No. 427/2018 —WHEREAS, it appears to the Government of Kerala that the land specified in the Schedule below is needed or likely to be needed for a public purpose, to wit for the land acquisition for the construction of Dumping yard in Kothamangalam Village of Emakulam District;

AND WHEREAS, in exercise of the powers conferred in sub-section (1) of section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), Government of Kerala have decided to conduct a Social Impact Assessment in the area specified in the Schedule below.

Now, THEREFORE, sanction is accorded to the District Level Social Impact Assessment Unit, Youth Social Service Organisation (YSSO), Social Service Centre, MA College P. O., Kothamangalam to conduct a Social Impact Assessment Study and to prepare a Social Impact Management Plan as provided in the Act. The process shall be completed within a period not exceeding two months in any case.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Rules has come into force on 19-9-2015 and as per Rule 10 notifying a Social Impact Assessment Unit for conducting Social Impact Assessment Study is required.
