WHEREAS, under sub-section (1) of Section 11 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013, Notification in Kerala Extra Ordinary Gazette No. 466 dated 11/02/2020 and Mangalam and Kerala Kaumudi dailies dated 22/02/2020 in respect of the land specified in the schedule below has been published;

And WHEREAS, the appropriate Government is satisfied after consideration the report made by the Collector under sub-section (1) of Section 15 of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013, that the land specified in the schedule below has to be acquired for a public purpose;

Now, THEREFORE, the Appropriate Government hereby declares under Section 19 of the Act, that the land specified in the Schedule below and measuring 0.9700 hectares to be the same, a little more or less, is needed for a public purpose, to wit Vadakkekotta Metro Station for Kochi Metro Rail Project acquisition and direct the Special Tahsildar(LA) No.1, Kochi Metro Rail Project, Kakkannad, to take order for the acquisition of the land;

A plan of the land is kept in the Office of the Special Tahsildar(LA) No1, Kochi Metro Rail Project, Kakkannad, and may be inspected at any time during office hours.
