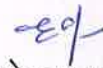

Request for Proposal (RFP)

1. Background

District Administration Palamu invites Expression of Interest for the project of “**Establishment of Strawberry and Multiple-Fruit Processing for 1000 LPH Capacity**” in Palamu District. This project seeks to install end to end solution for pulp processing of Fruits such as Strawberry, Mango and Orange. It includes the facility of cold storage, pulp processing and storage facility of total processed produced. At present, the farmers in Palamu District cultivate raw strawberry fruit in large quantity (Currently, 75-acre land, however it has expected to expand in more than 200-acre land) that requires processing which can help to multiply in their income.

The pulp processing unit and its related facility will be installed in the proportion of 1000 LTH capacity. The machinery of each Unit Facility (cold storage, pulp processing and storage facility) will be decided after Pre-Bid Meeting. This unit facility will be installed Palamu District; however, locality can be in Hariharganj or Medininagar or Lesliganj Block as per availability of government land and feasible in terms of supporting resources.

2. Objective of setting up Pulp Processing Unit

The main objective of setting up **Pulp Processing Unit** is as follow:

- Introduce technology driven common facility for Pulp Processing during strawberry and mango season, comprising of a packhouse, treatment / processing facility (Hot Water Treatment and Vapor Heat Treatment), blast chiller, cold storage, ripening chamber, laboratory and pulping facilities to growers, processors and exporters.
- Reduce the post-harvest losses of Fruit/Horticulture produce during harvest and activities thereafter to an acceptable level along with improved quality and shelf life of the products;
- Improve and delivering better quality of Strawberry and mangoes to local as well as global markets;
- Bridge the gap between growers and exporters/bulk buyers;
- Explore options of alternate mode of financing for strawberry and mango growers

3. Scope of Work

There are essentially two types of work need to be done under this project.

- 3.1. Physical Building Establishment
- 3.2. Machinery Facility Installation
- 3.3. Certification of Unit

3.1. Physical Building Establishment

Under this sub head, we are seeking to established following Unit

1. Pack house
2. Cold Storage
3. Blast Chiller
4. Ripening Chamber
5. Factory area (for pulp production etc.)
6. Staff Stay room/guest room
7. Laboratory for Quality Control and Microbiology
8. Farmers/growers training cell
9. Office and admin area j. Service area k. Common utilities area

The above nine units shall be established to run the pulp unit facility. If any additional unit is required which is not included in the above mention nine, shall be consider during the pre-bid meeting if any Bidder suggest during their presentation. Which will be updated in Corrigendum.

3.2. Machinery Facility Installation

The Machinery installation and its related equipment details shall be given the Bidders during the pre-bid meeting and present how to achieve 1000 LPH capacity production of Pulp. The details of machine shall be provided on the following Performa:

There are following head mentioned which need to be include at their presentation during the pre-bid meeting moreover, **Bidders has to submit the final Technical and Financial Detail Project Report at the Final Bid Submission**

a. TOOLS AND PLANTS:

(Including working table or trays and all other accessories with quantity on higher side. No shortage should be experience.)

b. LABORATORY/TESTING EQUIPMENTS:

With all required facilities recommended within the plant as the area will not help to get any out sourcing.

c. COLD STORAGES

Cold Storage Unit can be multiple with different capacity. Its interior design will be set up for Strawberry and Mango fruit. Raw fruit storage and processed produced storage are expected to store in different temperature. These are basic necessity which need to consider in this project.

d. **WATER REQUIREMENTS:**

Water requirement calculation shall be clearly mentioned in Bidder's Proposal with respect to total production capacity; so that, District Administration will provide suitable locality where required water quantity shall be efficient. In addition to it, RO Plant capacity has to clear in the project

e. **Packing section:**

Bidder shall clearly mention in their proposal about the machine specification, capacity, space required, power requirement etc.

Please try to avoid recommending plastic packages.

ANY OTHER FIXED ASSETS TO BE GENERATED LIKE MACHINE, MOTORS, GENERATORS, and so on

f. **Labour requirement:**

In the proposal total requirement of man power has to be mentioned clearly with their required skill and work responsibility

- Management staff like Production Manager with qualification and approximate salary
- Supervisory staff Nos. with salary payable
- Skilled workers
- Unskilled laborers

3.3 Certification/ Licence

- ISO/ISI Certification
- FSSAI Certification
- Trade Licenses Certification
- Pollution Control Certification
- Electricity Clearance etc.

If any other additional necessary Certification is required, it will be done by Bidder.

4. Pre-Bid Meeting and Issue of Corrigendum

- a. A Nodal Officer notified by the District Administration will endeavour to provide timely response to all queries. However, the District Administration makes no representation or warranty as to the completeness or accuracy of any response made in good faith, nor does the District Administration undertake to answer all the queries that have been posed by Bidders.
- b. At any time prior to the last date for receipt of bids, the District Administration may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the RFP Document by a corrigendum.
- c. A Meeting will be held on 31.03.2020. In this meeting interested Bidder will present their proposal with detail specification of Machinery & Unit Establishment. It includes Technology brief and Process Flow of work and expected budget requirement to establish Pulp Processing Unit in Palamu District, Jharkhand. Bidder will have to ensure how they will make Successful Functional Unit.
