

However, he alleged that opposite parties has created a border dispute, so for permanent solution, applicant wants measurement & demarcation of his land, if dispossession is found by opposite parties namely Jitendra Paswan s/o Late Bachchu Paswan & Gorakh Paswan s/o Late Bhaduka Paswan then that area should be restored to applicant.

The learned advocate of opposite party did not file written statement but orally in court, he agreed for measurement of disputed. So learned advocate commissioner Sri P.C. Maharaj was directed to measure & demarcate the disputed land and accordingly he submitted the report.

However, opposite parties were given sufficient opportunities to express their view in relation to measurement report but, they didn't turn up. So on request of applicant, it is directed that both the parties should abide by measurement report submitted by Sri P.C. Maharaj and this report will be part of order.
