

Learned advocate of opposite parties has given written statement & written argument and has mentioned that a case No-64/2014-2015 was filed by op of this case as applicant in that case was Kameshwar Singh vrs Nagendra Singh and order was passed by this court on 30.06.2016. He has attached order of case No-64/2014-2015 and has informed that disputed land in that case is same as in this case. so he has pleaded for dismissal of the case.

So after looking the documents produced by opposite parties, it was found that disputed khata & Plot in this case & in Case No-64/2014-2015 are same, so on this ground claim of op seems to be correct. So this court can not give any relief to applicant. So the claim of applicant is rejected & case is dismissed.
