Order under section 144 Cr.PC

Whereas, it has been brought to the notice of the undersigned by the Health Authorities that a person resident of Ward No. 11 of Municipal Council, Kullu has been reported positive of COVID-19 at PGIMER, Chandigarh. Before reporting positive, the said person was residing at Ward No. 11 for some time, as such, there is an imminent danger of spread of COVID-19 in the other part of said urban area and there is need to take strict measures to stop the further spread of COVID-19, which if not taken immediately can endanger human life and safety.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notices upon all persons residing in the jurisdiction of the areas mentioned below is not practicable and possible and, therefore, it is necessary and expedient to proceed under section 144 of the Code of Criminal Procedure, 1973.

Therefore, in view of the above circumstances and as a containment measures, I, **Dr. Richa Verma, IAS, District Magistrate Kullu**, in exercise of the powers vested in me under section 144(1) of the Code of Criminal Procedure, 1973, do hereby order and direct the **complete sealing of the area of the area of containment zone** in the following manner:-

It is further ordered that:-

1. Under no circumstances shall there be any ingress/outgress of any person or vehicle from the containment zone except for persons/vehicles involved in enforcement of containment plan and medical emergency.
2. The supply of the essential goods in containment zone shall be made by the authorities through home delivery.
3. No persons shall leave their home on foot or through vehicle or travel around, roam around and stand on any public path or place in the afore mentioned Containment Zone.

This order shall come into effect immediately and shall remain in force till further order.

Any violation of this order will attract provision of section 188 of Indian Penal Code and the violator can also be prosecuted under section 269 and 270 of Indian Penal Code.


