**ORDER UNDER SECTION 144 Cr. P.C**

Whereas, it has been brought into the notice of the undersigned by the Health Authorities and Tehsildar Kullu that a positive case of **COVID-19** has been found in **Ward No. 02 of Gram Panchayat, Neoli**, Tehsil Kullu, District Kullu. Therefore, there is an imminent danger of spread of **COVID-19** in the other parts of said ward and need to take strict measures to stop the further spread of **COVID-19**. It has become inevitable, to take action, which if not taken immediately, can endanger human life and safety.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notices upon all persons residing in the jurisdiction of the areas mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed under section 144 of the Code of Criminal Procedure, 1973.

And, therefore, in view of the above circumstances and as a containment measure, **I, Dr. Amit Guleria, HAS, Sub Divisional Magistrate, Kullu, District Kullu (Himachal Pradesh)**, in exercise of the power vested in me under section 144(1) of the Code of Criminal Procedure, 1973, do hereby order and declare the complete sealing of some area of Ward No. 2, Gram Panchayat Neoli, of Tehsil Kullu, Sub Division Kullu, District Kullu, H.P. as containment zone and buffer zone in following manner:-

No.	Name of Sub Division	Containment Zone	Buffer Zone
1	Kullu	Boundary of house of the late Sh. Ghanu Ram i.e in the North from common path to the house of Sh. Ghanu Ram toilet to the south and in the East from common path to the other path in the West (excluding paths).	Remaining area of Ward No. 2 Gram Panchayat, Neoli.

**It is further order that:-**

1. Under no circumstances shall there be any ingress/outgress of any person of vehicle form the containment zone expect for persons/ vehicle involved in enforcement of containment plan, essential services and medical emergency.
2. The Supply of the essential goods in containment zone shall be made by the authorities through home delivery.
3. No persons shall leave their home on foot or through vehicle or travel around, room around and stand on any public path or place in the afore mentioned containment zone.

This order shall come into effect immediately and shall remain in force till further order.

Any violation of this order will attract provision of section 188 of Indian Penal Code and the violator can also be prosecuted under section 269 and 270 of Indian Penal Code.
