**ORDER UNDER SECTION 144 Cr. P.C**

Whereas, it has been brought into the notice of the undersigned by the Health Authorities and Tehsildar Kullu vide office letter No. 1494/RT,1495/RT, 1496/RT, 1497/RT, 1498/RT,1499/RT & 1500/RT dated 24.12.2020 that some positive cases of **COVID-19** have been found in Tehsil Kullu, Sub Division Kullu, District Kullu. Therefore, there is an imminent danger of spread of **COVID-19** in the other parts of said ward and need to take strict measures to stop the further spread of **COVID-19**. It has become inevitable, to take action, which if not taken immediately, can endanger human life and safety.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notices upon all persons residing in the jurisdiction of an area mentioned below is not practicable and possible. Therefore, it is necessary and expedient to proceed under section 144 of the Code of Criminal Procedure, 1973.

And, therefore, in view of the above circumstances and as a containment measure, I, **Dr. Amit Guleria, HAS, Sub Divisional Magistrate, Kullu, District Kullu (Himachal Pradesh)**, in exercise of the power vested in me under section 144(1) of the Code of Criminal Procedure, 1973, do hereby order and declare following areas of Tehsil Kullu, Sub Division Kullu, District Kullu, H.P. as containment zone and buffer zone in following manner:-

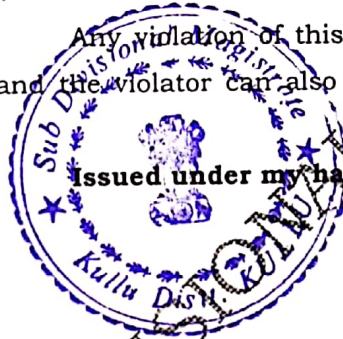
**It is further order that:-**

1. Under no circumstances shall there be any ingress/outgress of any person of vehicle from the containment zone except for persons/ vehicle involved in enforcement of containment plan, essential services and medical emergency.
2. The Supply of the essential goods in containment zone shall be made by the authorities through home delivery.
3. No persons shall leave their home on foot or through vehicle or travel around, room around and stand on any public path or place in the afore mentioned containment zone.

This order shall come into effect immediately and shall remain in force till further order.

Any violation of this order will attract provision of section 188 of Indian Penal Code and the violator can also be prosecuted under section 269 and 270 of Indian Penal Code.
