

Proceeding of meeting of Jan Manch held on 23.01.2021 under the Chairmanship of Dr. Amit Guleria, HAS, Sub Divisional Magistrate, Kullu.

At the very outset chairman welcomed the officers attended the meeting, the list of officers attended the meeting is annexed at Annexure-A, The chairman apprised that the Jan Manch is being held on 30.01.2021 at Govt. Senior Secodary School, Bashing and Gram Panchayat selected vide letter No. 182-88/Gr. Cell dated 22.01.2021 issued by worthy Deputy Commissioner, Kullu are **Bandrol, Jaindaur, Bashing, Kothi Sari, Bastori, Nalach & Banogi, Benchi, Shirar and Raison**

As per discussion held in the meeting it has been decided that '**Pre-Jan Manch**' will be intiated for the resolution of the grievances of the general public. Schedule of **Pre Jan Manch** is as under:-

The Chairman directed all the officers to Carry out the Pre Jan Manch activities as per above schedule and ensure to redress the grievance of general public on spot. The BDO, Kullu and Naggarr has specifically been directed to make all necessary arrangements for Pre-Jan Manch as per above schedule as well as maximum gathering of public in Pre Jan Manch through their Panchayat Scretaries. It has also been directed that a separate file be maintained for taking note of grievances of general public and uploading on e-samadhan by the SEBPO and Computer Operator, MNREGA on the office of the Block Development Officer, Kullu. It shall be noted that grievances resolved on spot also be noted down and entered in e-samadhan so as to ensure the accurate reflection of the efforts put in by the concerned

departments during Pre-Jan Manch phase. Specific directions have been issued to all line departments for utilization of Pre-Jan Manch phase for getting all important schemes of the Govt. in the catchment area inspected by the departmental staff as per schedule mentioned above. The compliance will be collected by the Block Development Office, Kullu and Nagar and should be received in this office on 29.01.2021 accordingly .

The Departments of health & Ayurveda will ensure the arrangements of medical checkups and they will ensure the thermal scanning in the entry point of Jan Manch venue. The Jal Shakti Vibhag will arrange the drinking water at the Jan Manch venue. For the safety of COVID-19 social distancing will be ensured and the stall of departments should also be in the distance of each other.

On the similar lines, condition of roads, power supply, drainage, Schools, Institutions under departments like health, veterinary, food and civil supplies etc. will be inspected by the officers of concerned departments. The departments of Public works, Jal Shskti, State Electricity Board are directed that the officers of the rank of Assisatant Engineer and above will attend the Pre-Jan Manch Phase without fail.

The meeting concluded with a vote of thanks to all from the chair.
