Whereas, Order dated 20.04.2021 was issued by the Disaster Management Cell, Government of Himachal Pradesh to arrest the spread of COVID-19 pandemic in the State for compliance with order and guidelines dated 23.03.2021 issued by the Ministry of Home Affairs, Government of India for containment of COVID-19.


Whereas, after a careful review of the recent spike in COVID-19 cases it is evident that it still remains a public health risk and caution is necessary for the containment of spread of COVID-19 in this District.

Now therefore, after considering current situation of the COVID-19 pandemic, overall circumstances and in pursuance to the Order No. (DMC)(C)20-2/2021-COVID-III, dated 20th April, 2021 issued by the Disaster Management Cell, Government of Himachal Pradesh I, Dr. Richa Verma, IAS, District Magistrate, Kullu reiterate the restrictions contained in the order dated 20.04.2021 and in addition to this further order to close all the existing functional Libraries (Government & Private) to remain closed till further order.

Any person violating this order will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC, and other legal provisions as applicable.

This order shall remain in force, in all parts of the District with immediate effect till further orders.
