

Press Release by the District Collector

Applications are invited by the Department of Social Defence from the eligible “**Woman**” candidates who possesses the following qualifications and residents of the respective Districts for appointment of Social Worker Members of the Juvenile Justice Board constituted under the provisions of Juvenile Justice (Care and Protection of Children) Act, 2015. Social Worker Members for Juvenile Justice Board are to be appointed on honorarium basis of which one shall be a woman.

The applicants should have been actively involved in health, education or welfare activities pertaining to children for atleast seven years or a practicing professional with a degree in child psychology, psychiatry or law. The age of the applicant should not be less than 35 years and not completed 65 years. A person shall be eligible for appointment as Social Worker Member for a maximum of two terms, which shall not be continuous.
