ORDER

WHEREAS, the Dy. Collector & SDM, Bicholim-Goa vide letter referred at Sr.No.(1) alongwith a letter from Executive Engineer, WDXXIII, PWD, Bicholim-Goa has requested for diversion of road via Haturly-Naraoa-Bicholim road, for taking up the construction of retaining wall near Sushen Datta Mandir at Haturli in Mayem Constituency of Bicholim Taluka from 02/11/2020 to 31/12/2020.

AND WHEREAS, the Dy. Supdt. of Police Traffic (North), Altinho, Panaji has recommended for diversion of traffic for the period upto 31/12/2020 for construction of retaining wall near Sushen Datta Mandir at Haturlim in Mayem Constituency of Bicholim Taluka.


NOW THEREFORE, in exercise of the powers conferred on me under Sections 115 & 116 of the Motor Vehicles Act, 1988, and as recommended by the Dy. Superintendent of Police (Traffic), Altinho Panaji I, **R. Menaka, IAS**, District Magistrate, North Goa hereby order diversion of traffic for the period upto 31/12/2020 for construction of retaining wall near Sushen Datta Mandir at Haturlim in Mayem Constituency of Bicholim Taluka, subject to the following conditions:-

- 1) The PWD Officials/Contractor shall deploy maximum Traffic Marshals round the clock for guiding the motorist/regulating vehicular traffic.
- 2) The PWD Official/Contractor shall install red lamps/lights at the construction site for clear visibility during night time.
- 3) No construction material should be dumped on the road causing obstruction to the road users and motorists.
- 4) Sufficient traffic signages/directional boards shall be erected at all the diversion points for the information of motorists and other road users.

- 5) The PWD /Contractor under taking the work of retaining wall, before blocking the approach road to any house or colony, should construct temporary pathway to allow to and fro movements of the vehicles of the residents.
- 6) Wide publicity about the above diversion shall be given through Press/Media for the information of the motorists in general and the residents in particular.
- 7) NOC from Bicholim Police Station should be obtained.
- 8) Material used for barricading the road shall be pasted with fluorescent paint/tape for illuminating the same during the night time.
- 9) After completion of the work entire place should be cleaned from all types of debris, mud etc and the road should be brought down to its normalcy for the use of motorists and other road users.
- 10) Material used for barricading of road should be removed immediately and the road shall be thrown open for vehicular flow as soon as the work is completed.
- 11) The work should be completed before 31/12/2020 itself and the road should be resurfaced for normal use.
- 12) The contact No. of the Contractor / Supervisor or the responsible person should be displayed at all closure/diversion points so as to enable him/her to contact if any emergency situation arises.
- 13) Permission from other competent authorities should be obtained well in advance.
- 14) This permission is subject to cancellation/revocation at any moment.
