
Terms & Conditions for supply of CBJ Cows to BBR & BM Farm, Remuna

A. Criteria & Qualities of CBJ Jersey Cows to be purchased:-

1. The milch cows should have all phenotypical breed characteristics of CB jersey cow.
2. The cows must be in 1st /2nd lactation and up to six nos. of permanent teeth.
3. The cows should have a calf on foot preferably within 2 months of age.
4. The cows should yield minimum 14lts. of milk per day (the milk yield will be judged on an average of three consecutive milking i.e. morning, evening, morning).
5. The cows should be free from all sorts of contagious diseases, reproductive diseases, udder disorders and other vices.
6. The bidder should provide breeding history of the cows if possible.

B. Rules & Regulations of sealed quotation process:-

1. Availability of quotation application form:-
Application form will be available from Dt.15.10.2019 to Dt.22.10.2019 date in all official working days 10A.M. to 5:30P.M. from O/O Manager BBR & BM Farm, Remuna, Balasore, or can be downloaded from web portal www.baleshwar.nic.in (Application form consists -Application, Criteria & qualities of CB Jersey cows to be purchased, rules regulation of sealed quotation).
2. Receipt of application form-last date receipt of application duly filled in all respect along with bank draft for earnest money is dt.22.10.2019 at 12.00 Noon.
3. Date & Place of opening of sealed quotation:- O/O Chief District Veterinary Officer, Balasore on dt.22.10.2019 at 4P.M.
4. Cost of quotation application Rs.500/- only.
5. Earnest money to be deposited along with application form Rs.8000/- (Rupees Eight Thousand) only (Refundable) in the name of Farm Manager, BBR & BM Farm, Remuna payable at SBI Balasore.
6. Cost of cows to be mentioned on the basis of per liter of milk yield.
