



QUOTATION /TENDER CALL NOTICE

Sealed quotations/tenders are invited from interested reputed Travel agencies / Tour Operators or private individuals for providing 01 nos of Non AC/AC Diesel driven vehicles having sitting capacity not more than ten including driver , which shall confirm to the Terms and Conditions (Annexure-II) for official use in Baliapal Block Office on monthly rent basis:

- 1) The vehicle must be in Road worthy condition , shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness certificate valid Contract carriage permit, Proof of up to date Tax payment etc. which are mandatory for plying of vehicle.
- 2) The driver of vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle .
- 3) The driver should be well behaved , gentle and obedient in nature.
- 4) A sum of Rs.5000/-shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favor of the Block Development Officer, Baliapal submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
- 6) The vehicle must achieve a fuel efficiency of 10 KMs per litre (as per Finance Department office memorandum No. 30464/F dated 06.09.2019)
- 7) The details of the make and year of manufacture of the vehicle registration no. mileage (Kms covered per litre ) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender(Annexure-III).
- 8) The quotation completed in all respect should reach the undersigned on or before 13.03.2020 by 2 PM and shall be opened on the same day at 4 PM in presence of the bidders or their authorized representatives.
- 9) In the event of acceptance of quotations the Service Provider should provide the vehicle on or before 31.03.2020 .
- 10) The application form of quotation / tender containing General Bid Information & Terms and Conditions for Hiring of Vehicles etc. will be available with Baliapal Block Office on payment of Rs. 100/- from 28.02.2020 to 13.03.2020 or can be downloaded from Odisha Govt.Website www. Odisha.gov.in from Dt.28.02.2020 to Dt.13.03.2020. In case the application form is downloaded from Govt. website, the applicant shall furnish a Demand Draft for an amount Rs.100/- (Rupees One Hundred ) only towards the cost of application along with the application.
