Sub: - Land Acquisition – Irrigation Projects – Dathojipet village of Ramadugu(M) – Acquisition of lands for excavation of D1 of LMC KM 8.950 to 9.500, 9R Minor of D1 of LMC from KM 0.000 to 2.600, 1L SM of 9R Minor of D1 of LMC from KM 0.200 to 0.300, 10R Minor of D1 of LMC from KM 0.000 to 2.350 under Sripada Yellampalli Project – Declaration U/sec. 19 (1) of the RFCTLARR Act 30/2013 published on 11-03-2019 for an extent of (8-29 ½) acres – Extension of time of Declaration beyond (12) months – Orders - Issued .

ORDER:

The Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar through the reference 3rd read above has submitted that, the Declaration was published on 11-03-2019 for acquisition of (8.29 ½) acres for excavation of D1 of LMC KM 8.950 to 9.500, 9R Minor of D1 of LMC from KM 0.000 to 2.600, 1L SM of 9R Minor of D1 of

LMC from KM 0.200 to 0.300, 10R Minor of D1 of LMC from KM 0.000 to 2.350 under Sripada Yellampalli Project in the limits of Dathojipet village of Ramadugu Mandal U/sec. 19 (1) of the RFCTLARR Act 30/2013 (Central Act 30/2013) as amended by the Telangana Amendment Act 2016 (Act No. 21/2017).

Further the Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar has submitted that the Award could not be passed within the stipulated time i.e. from the date of publication of Declaration due to various reasons & Non availability of funds. Hence the SDC has requested to accord permission for extension of time of the Declaration for another (12) months U/sec. 25 of the RFCTLARR Act 2013, so as to enable to pass the Award for extent of (8-29 ½) acres situated at Dathojipet village of Ramadugu Mandal.

On verification of records, it is revealed that the Declaration was approved and published on 11-03-2019. As such the Authorized Officer / Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar shall make an award within a period of (12) month from the date of publication of Declaration. But the same could not be done by the Authorized Officer / Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar.

The circumstances reported by the Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar has been examined with reference to the record and justified the same, consequently the extension of the time for Declaration published on 11-03-2019 for acquisition of land for excavation of D1 of LMC KM 8.950 to 9.500, 9R Minor of D1 of LMC from KM 0.000 to 2.600, 1L SM of 9R Minor of D1 of LMC from KM 0.200 to 0.300, 10R Minor of D1 of LMC from KM 0.000 to 2.350 under Sripada Yellampalli Project in the limits of Dathojipet village of Ramadugu Mandal which is a flagship programme of the Government and contention of the Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar is hereby concurred.

In view of the above circumstance and in exercise of the powers conferred U/sec. 25 of the RFCTLARR Act 2013, it is hereby ordered to extend the validity of the Declaration published on 11-03-2019 in notification No. G1/1842/2018, dt:25-02-2019 for acquisition of (8-29 ½) acres situated at Dathojipet village of Ramadugu Mandal for further period of (12) months i.e. from 10-03-2020 to 09-03-2021. The Authorized Officer / Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar shall take necessary action for acquisition of required land at the earliest.
