Sub: - Land Acquisition – Irrigation Projects – Manakondur (M) – Vegurupalli (V) - Acquisition of land for Construction of High Level Bridge across Manair Vagu at KM 5/8 of Sulthanabad, Neerukulla Road and at KM 3/6 of Veldhi – Vegurupalli Road – Declaration U/sec. 19 (1) of the RFCTLARR Act 30/2013 published on 22-01-2019 for an extent of (08-23 ½) acres – Extension of time of Declaration beyond (12) months – Orders - Issued .

ORDER:

The Revenue. Divisional Officer, Karimnagar through the reference 3rd read above has submitted that, the Declaration was published on 22-01-2019 for acquisition of (08-23 ½) acres for Construction of High Level Bridge across Manair Vagu at KM 5/8 of Sulthanabad, Neerukulla Road and at KM 3/6 of Veldhi – Vegurupalli Road U/sec. 19 (1) of the RFCTLARR Act 30/2013;(Central Act 30/2013) as amended by the Telangana Amendment Act 2016 (Act No. 21/2017).

Further the Revenue Divisional Officer, Karimnagar has submitted that the Award could not be passed within the stipulated time i.e. from the date of publication of Declaration due to various reasons & Non deposit of funds. Hence the Revenue Divisional Officer, Karimnagar has requested to accord permission for extension of time of the Declaration for another (12) months U/sec. 25 of the RFCTLARR Act 2013, so as to enable to pass the Award for extent of (08-23 ^{1/2}) acres for Construction of High Level Bridge across Manair Vagu .

On verification of records, it is revealed that the Declaration was approved and published on 22-01-2019. As such the Authorized Officer / Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar shall make an award within a period of (12) months from the date of publication of Declaration. But the same could not be done by the Authorized Officer / Revenue Divisional Officer, Karimnagar.

The circumstances reported by the Revenue Divisional Officer, Karimnagar has been examined with reference to the record and justified the same, consequently the extension of the time for Declaration published on 22-01-2019 for acquisition of land for Construction of High Level Bridge across Manair Vagu at KM 5/8 of Sulthanabad, Neerukulla Road and at KM 3/6 of Veldhi – Vegurupalli Road ,which is a flagship programme of the Government and contention of the Revenue Divisional Officer, Karimnagar is hereby concurred.

In view of the above circumstance and in exercise of the powers conferred U/sec. 25 of the RFCTLARR Act 2013, it is hereby ordered to extend the validity of the Declaration published on 22-01-2019 in notification No. G2/2862/2016, dt:17.01.2019 for acquisition of (08-23 ^{1/2}) acres for Construction of High Level Bridge across Manair Vagu at KM 5/8 of Sulthanabad, Neerukulla Road and at KM 3/6 of Veldhi – Vegurupalli Road for further period of (12) months i.e. from 22-01-2020 to 21-01-2021. The Authorized Officer /Revenue Divisional Officer, Karimnagar shall take necessary action for acquisition of required land at the earliest.
