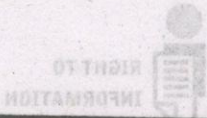

ORDER:

The Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar through the reference 2nd read above has submitted that, the Notification U/s 11(1) of the RFCTLARR Act 30/2013 (Central Act 30/2013) as amended by the Telangana Amendment Act 2016 (Act No. 21/2017) was published on 27-02-2019 for acquisition of Ac. 1.24 gts., situated at Gangadhara (v) of Gangadhara Mandal for excavation of 1R Minor of D1 of LMC from KM.0.000 to KM.1.950. Out of which no land has been acquired.

Further the Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar has reported that, the Declaration proposals could not be submitted within the stipulated time from the date of publication Preliminary Notification, due to Non Availability of funds. Hence the SDC has requested to extend the validity of the PN published on 27-02-2019 for further period of (12) months i.e., from 26.02.2020 to 25.02.2021 for initiating further action.

The report and reasons submitted by the Authorized Officer/SDC has been examined with reference to the record in not submitting the Declaration consequent on issue of Preliminary Notification published on 27-02-2019 for acquisition of excavation of 1R Minor of D1 of LMC from KM.0.000 to KM.1.950, hence his report/contention is hereby concurred.

In view of the above circumstance and in exercise of the powers conferred U/sec. 19(7) of the RFCTLARR Act 2013, it is hereby ordered to extend the validity of the Notification published on 27-02-2019 in notification No. G1/198/2019, dt:13-02-2019 for acquisition of Ac. 1.24 gts. situated at Gangadhara village of Gangadhara Mandal for a further period of (12) months i.e. from 26.02.2020 to 25.02.2021. The Authorized Officer/Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar shall take necessary action for acquisition of required land at the earliest.
