ORDER:

The Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar through the reference 2nd read above has submitted that, the Notification U/s 11(1) of the RFCTLARR Act 30/2013 (Central Act 30/2013) as amended by the Telangana Amendment Act 2016 (Act No. 21/2017) was published on 23.03.2019 for acquisition of Ac. 11.12 ^{1/4} gts., situated at Kurikyala (v) of Gangadhara Mandal for excavation of for excavation of D3 of RMC from KM 0.000 to 1.275 & 1R Minor of D3 of RMC from KM 0.000 to 1.250 Out of which no land has been acquired.

Further the Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar has reported that, the Declaration proposals could not be submitted within the stipulated time from the date of publication Preliminary Notification, due to non availability of funds, the consent / General award has not been passed in time and requested to extend the validity of the PN published on 23.03.2019 for further period of (12) months i.e., from 22.03.2020 to 21.03.2021 for initiating further action.

The report and reasons submitted by the Authorized Officer/SDC has been examined with reference to the record in not submitting the Declaration consequent on issue of Preliminary Notification published on 23.03.2019 for excavation of for excavation of D3 of RMC from KM 0.000 to 1.275 & 1R Minor of D3 of RMC from KM 0.000 to 1.250, hence his report/contention is hereby concurred.

In view of the above circumstance and in exercise of the powers conferred U/sec. 19(7) of the RFCTLARR Act 2013, it is hereby ordered to extend the validity of the Notification published on 23.03.2019 in notification No. G1/437/2019, dt: 06.03.2019 for acquisition of Ac. 11.12 ^{1/4} gts. Situated at Kurikyala village of Gangadhara Mandal for a further period of (12) months i.e from 22-03-2020 to 21.03.2021. The Authorized Officer/Special Deputy Collector, LA and R&R, Irrigation Projects, Karimnagar shall take necessary action for acquisition of required land at the earliest.
