ORDER:

The Revenue Divisional Officer, Karimnagar through the reference 3rd read above has submitted that, the Declaration was published on 08.04.2019 for acquisition of (26.27 $\frac{3}{4}$) acres for excavation of Minor- 23R of Distributory –4 Right Side Main Canal from K.M. 0.570 to K.M. 5.650 under Gouravelli Canal Project in the limits of Chigurumamidi village and Mandal U/sec. 19 (1) of the RFCTLARR Act 30/2013 (Central Act 30/2013) as amended by the Telangana Amendment Act 2016 (Act No. 21/2017).

Further, the Revenue Divisional Officer, Karimnagar has submitted that, as envisaged under Rule-7(a) of the "The Telangana State Land Acquisition (Consent Award, Voluntary Acquisition and Lump-sum Payment towards R&R) Rules-2017, a Notice in "Form-D" has been issued on 25-06-2018 and published in the locality/ village, calling the interested persons of the lands coming under acquisition to state their willingness for settlement of compensation through "DLNC" under package deal rate. While the issue is under process. The DLNC and Award enquiry are under process. The entire revenue officials were busy with Election works since September, 2018 to February, 2020 (i.e. TSLA Elections - 2018, General Elections - 2019, Rural and Urban Local body Elections & etc). It may not be possible to pass the Award in the remaining time by attending due works like determination of market value of the similar lands by discarding sales, settlement of compensation under DLNC, settlement of claims and receiving of all estimates of the things attached with respect to the land, taking note approval by the Collector before passing the award & etc. The required funds are also not readily available for passing the Award and payment of compensation to the concerned land owners. As such, it may not be possible to pass the Award within twelve months (i.e. 1-year) from the date of publication of "Declaration" U/s 19(1) of the LARR Act, 2013 i.e. on or before 07-04-2020.

On verification of records, it is revealed that the Declaration was approved and published on 08.04.2019. As such the Authorized Officer / Revenue Divisional Officer, Karimnagar shall make an award within the period of (12) months from the date of publication of Declaration. But the same could not be done by the Authorized Officer / RDO, Karimnagar.

The circumstances reported by the Revenue Divisional Officer, Karimnagar have been examined with reference to the record and justified the same, consequently the extension of the time for Declaration published on 08.04.2019 for acquisition of land for excavation of Minor- 23R of Distributory -4 Right Side Main Canal from K.M. 0.570 to K.M. 5.650 under Gouravelli Canal Project in the limits of Chigurumamidi village and Mandal which is a flagship programme of the Government and contention of the Revenue Divisional Officer, Karimnagar is hereby concurred.

In view of the above circumstance and in exercise of the powers conferred U/sec. 25 of the RFCTLARR Act 2013, it is hereby ordered to extend the validity of the Declaration published on 08.04.2019 in notification No. G1/1356/2018, dt:20.03.2019 for acquisition of (26.27 $\frac{3}{4}$) acres situated at Chigurumamidi village and Mandal for further period of (12) months beyond 07.04.2020 (i.e. from 08.04.2020 to 07.04.2021). The Authorized Officer / Revenue Divisional Officer, Karimnagar shall take necessary action for acquisition of required land at the earliest.
