1. Only the Firm registered in INDIA is eligible to participate in tender.
2. Distributor shall compulsorily furnish the authorized letter of the company.
3. Tender should be submitted in the prescribed form attached to these conditions before 2.00PM on 03.09.2020
4. Only one tender should be submitted for one firm duly submitting rate for the individual.
5. Tender shall be in the prescribed form only, which are serially numbered and sold by the DRDO-DRDA Karimnagar, Karimnagar District otherwise they are liable to be rejected. Tender forms are not transformable.
6. Tender form should be written clearly, duly signed and all corrections if any should be duly attested.
7. The bidder should indicate his address with telephone, Mobile and fax numbers and email ID for further correspondence, if required.
8. The envelope containing the quotations should be addressed to the District Rural Development Officer, Karimnagar District.
9. Tender forms can be submitted by person.
10. Tender received after the specified date i.e., 03.09.2020, 12.00PM will not be entertained.
11. Tender should provide information and documentary proof on Service Tax Registration and others required (to be enclosed with the tender form).
12. Tender will be opened (Financial Bid) after 11.00 AM on 04.09.2020 in District Collector Chamber Collectorate Karimnagar. The tender may choose to be present either in person or through an authorized representative at the time of opening.
13. All terms and conditions of state Government regarding the Tenders will be applicable.
14. The District Purchase Committee is competent to cancel, Modify, amend the terms and conditions, specification and quantities of the tender without prior notice and without assigning any reason what so ever and their decision will be final.
15. The successful Tenderer should sign the agreement on Rs. 100/- (Rupees One Hundred Only) Non Judicial Stamp paper within the Time as decided by the purchase committee. And should come with all samples at the time of agreement.
16. The Tenderer shall submit Part — I & II and Technical Bid (Cover — A) and Part — III financial Bid (Cover-B) in separate covers. The Tenderer shall put the sealed covers 'A' & 'B' in cover 'C' closed and sealed.
17. Financial bids will be opened only for the firms qualified in Technical bid.
18. EMD — 2% on quoted Bid cost at the time of tender (In shape of DD). This amount will be paid to supplier/successful bidder after completion of Guaranty and Warranty Period.
19. The bidder shall enclosed DD drawn for Rs. _____ /- (in words _____) in favour of "**District Rural Development Officer, DRDA Karimnagar**" from any Nationalized Bank towards EMD. Otherwise the bid will not be opened and evaluated and stands rejected.

20. Bid Price: All items shall include all taxes, installation, fixing and transportation to delivery point as mentioned in the bid documents. No additional transportation or fixing charges will be paid.
21. In warranty/ Guaranty period the Supplier has to attend all repairs or replacements.
22. Penalty will be imposed in case the successful bidder fails to deliver, fixing and installation as per the time frame fixed at the rate of Rs. 3000/- per day of delay.
23. Quality Check/specification check will be done by concerned Government agency.
24. Any discrepancies in the quality noticed by the government agency the DPC, have the authority for cancellations of order. In addition to the penal action against the firm. If the material is found to be not conforming to the specifications mentioned in the bid document and found to be substandard, defective etc. The material will not be accepted and supplier will have to replace the material at his own cost.
25. Mode of payment: eligible payment will be made to the firm after supply of all the items.
26. No deviation from specification given by District Rural Development officer, DRDA, Karimnagar available on the website of the District Collector official website (<http://karimnagar.telangana.gov.in/>) will be accepted.
27. Any attempt by a bidder to influence in the examination, evaluation, comparison and post qualification of the Bids or contract award decisions may result in the rejection of its bids.
