Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instruction to Bidders to qualify for the award of the contract.

- 4. According to provisions of Government Order No-26/2017/2778/78-2-2017-97 IT/2017 TC Date Bids must be accompanied with the copy of UTR(Unique Transaction Receipt) Bid Security(EMD) and tender cost of the amount specified for the work in the table.Bid Security and Tender Cost should be deposited online as per follows:-
  - **A. Cost of Bid Document:** As per Coloumn No-6(Non Refundable) to be deposited in account of UP e-tender Online account through e-tender portal by internet Banking only. All concerned please note that the bidding process will not move onward if the Bid Document's Cost(Tender Fee) is not paid through e-tender portal by internet Banking.
  - **B.Bid Security (EMD):** Bid must be accompanied with security of the amount specified for the work in that table as per Coloumn No-5.Bid security will be deposited in the account of UP E-tender online account through e-tender portal by internet banking only. All concerned please note that the bidding process will not move onward if the Bid Document's Cost(EMD) is not paid through e-tender portal by internet Banking. No other form of Bid security will be accepted.
  - **C**. The Bidders are required to submit the following:
  - i. Cost of Bid Document (Tender Fee):- Certificate of proof of payment in the account of UP E-tender online Account by Internet Banking which will be generated when payment made through e-tender portal by internet Banking.
  - **ii.** Bid Security (EMD):- Certificate of proof of payment in the account of UP E-tender online Account by Internet Banking which will be generated when payment made through e-tender portal by internet Banking.
- 5. The bids shall remain Valid for acceptance for a period of **Three Months** from the last date of submission of bids. Bids once submitted cannot be withdrawn.
- 6. E-tendering is to be adopted for this tender. Bidding documents can be downloaded from or uploaded to website http://etender.up.nic.in.
- 7. Bids must be submitted online (uploaded) on or before 12:00 Noon on dated 09.06.2020 and the technical bids will be opened online, that is, on dated 09.06.2020 at 03:30 pm. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day respectively, at the same time and validity of bid will be considered from the original date. The date and time of opening of the financial bid shall be notified on website. The Financial bids shall be accordingly opened online.
- 8. A pre-bid meeting shall be held in the Office of the Executive Engineer, Provincial Division, P.W.D., Etawah for each work on dated 05.06.2020 at 12.00 Noon corresponding to the respective package to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of 'Instructions to Bidders' of the bidding document.
- 9. A bidder must not have in his employment-
  - (i) The near relations (defined as first blood relations and their spouse of the bidder or the bidder's spouse) of persons listed in the Appendix to ITB.
  - (ii) Without Government permission any person who retired as gazetted officer within the last two years of rank and form the departments listed in the Appendix to ITB.

- 10. No Engineer of gazetted rank or other Gazetted Office employed in Engineering of Administrative duties in an Engineering Department of the State / Central Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the contractor or any his employees is found and time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the contractor's service.
- 11. Bid documents and other details consisting of qualification information and eligibility criteria of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the Contractor can-be seen in the office of the Executive Engineer mentioned in column 7 of the table corresponding to the respective package between hours of 11.00 am to 04.00 pm on any working day between 04.06.2020 to 09.06.2020 (upto 12:00 Noon).
- 14. Any bidder who is having criminal record is not allowed to participate in the bidding process.
- 13. Any bidder who is registered with the State Bar Council is not allowed to participate in the bidding process.
- 14. Each bidder is required to furnish an affidavit online on a non-judicial stamp paper of Rs. 100/- giving all information on prescribed Performa required for evaluation of the bidding capacity of the bidder.
- 15. Bidder must submit information/document on prescribed Performa i.e., T4, T5, T6 in original/ photocopy with each bid.
- 16. 1% Labour cess will be deducted from the Contractor Bill.
- 17. For SI. No. 1 work will be done by HMP only. The bidder must have ownership of HMP & Allied Machineries. The Plant will be established within 50 Km from work site after award of work. The Plant shall be established within 15 days from award of work.
- 18. For work at SI. No. 4 to 8 conditions of schedule 'C' will be applicable.
- 19. If the bidder submitted below rate tender as per BOQ then the additional security money will be taken as per GO No.: 622/23-12-2012-02/03T.C. Dated 08.06.2012 at the time of accepting tender.
  - (A) Upto 10% below rates in BOQ @ 0.50% per 1% below rate.
  - (B) In case of bidders quote the rate more than 10% below on BOQ than bidder has to provide extra 1% below rate.
- 20. In compliance of UP Govt. G.O No-1/2018/3070/78-2-2018/42 IT/2017(22)dated 03-01-2018, the bidder shall have to deposite/submit all documents such as Bid,Tender cost and bid security in the form of UTR in original to the Office of Executive Engineer concerned after the opening of technical & financial bid,both. If the bidder fails to produce above mentioned documents in original within the stipulated time, legal action shall be taken against the bidder along with Black Listing of the bidder.
- 21. As per direction of G.O. No.: 3460/23-7-08-14M.S.A./54T.C.3 Dt. 28.07.2008 SC/ST bidder can submit their bid with 2% security money of estimated cost & rest security money will be deposited at the time of agreement of bond.
- 22. GST shall be paid extra as per existing applicable rules.
- 23. Defect liability period will be Two years.
