**ORDER UNDER SECTION 34 OF DISASTER MANAGEMENT ACT. 2005**

Whereas, Government of Himachal Pradesh, Revenue Department, Disaster Management cell vide continuation Order No. Rev(DMC)(C)20-2/2020-COVID-19 dated 16<sup>th</sup> January, 2021, has issued certain amendments in the existing guidelines / directions to regulate the activities in order to curb the spread of COVID-19 cases which is endangering the life of citizens.

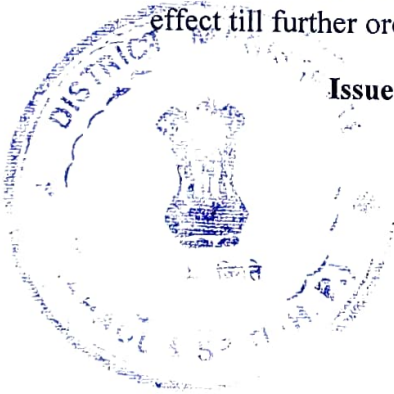
Now therefore, taking note of the above directions and after a comprehensive review of the current COVID-19 pandemic situation in the district, I, Pankaj Rai, IAS, District Magistrate, Lahaul & Spiti in exercise of the powers vested in me under Section 34 of the Disaster Management Act 2005, do hereby order the amendment to the order No.34/DDMA-2021 dated 06<sup>th</sup> January, 2021

**The following directions stand amended:**

Henceforth all social/ religious/ sports/ entertainment/ educational/ cultural gatherings, are allowed with a maximum gathering of 50% of the capacity, with a ceiling of 200 persons in closed spaces; and 50% of the size of the open grounds/spaces subject to compliance of all instructions, SOPs / advisories regarding social distancing and wearing of face covers etc.

This Order shall remain in force, in all parts of the district with immediate effect till further orders.
