ORDER

Sub: Office of the Regional Administrator, Mahe - Payment of Old Age Pension to fishermen for 3 months from April 2018 to June 2018 - Expenditure sanction - Accorded.

Whereas 175 beneficiaries in the Age Group Category 50-59 years, 248 beneficiaries in the Age Group Category 60-79 years and 20 beneficiaries in the Age Group Category 80 years and above have been granted OAP for the month of March 2018 under the scheme component "Grant of Old Age Pension for fishermen" under the scheme "Welfare and Relief for fishermen during lean seasons and natural calamities". Out of 175 beneficiaries in the Age Group Category 50-59 years, 2 beneficiaries have been removed from the list as they were shifted to Kerala during April 2018.


Whereas based on the age proof produced by the beneficiaries and found eligible for Age Group Category upgradation, the Assistant Director of Fisheries and Fishermen Welfare, Mahe has now proposed to upgrade 20 nos. of beneficiaries from Age Group 50-59 years category to 60-79 years category and 1 beneficiary from Age Group 60-79 years category to 80 years and above category from April 2018 onwards.

Therefore, in exercise of the powers conferred in G.O.Ms.No.47/F3/2014, dated 9.12.2014 Annexure-II of Finance Department, Puducherry, expenditure sanction of the undersigned is hereby accorded to incur an expenditure not exceeding **Rs.25,92,225/-** (Rupees twenty five lakh ninety two thousand two hundred and twenty five only) towards the payment of Old Age Pension to 441 existing beneficiaries of Mahe region for 3 months from April 2018 to June 2018 under the scheme component "Grant of Old Age Pension for fishermen" under the scheme "Welfare and Relief for fishermen during lean seasons and natural calamities" as detailed below:
