Sub: Office of the Regional Administrator, Mahe – Expenditure sanction towards construction of compound wall at the eastern side of Medial Officers' Quarters at Govt. General Hospital, Mahe – Corrigendum – Issued.

Whereas expenditure sanction towards the work "Construction of compound wall at east side of Medial Officers' Quarters at Govt. General Hospital, Mahe" was accorded vide Order 1<sup>st</sup> cited to incur an expenditure of **Rs.8,63,000/-** in the budget. Out of the amount sanctioned therein, **Rs.2,72,000/-** was booked by the Executive Engineer, PWD, Mahe towards the expenditure under the Head of Account shown in the sanction order during the financial year 2016-17.

2. Whereas the Head of Account under which the original sanction order accorded was inoperative during the financial year 2017-18, Corrigendum to the sanction order was issued to book the balance expenditure vide Order 2<sup>nd</sup> cited. Due to paucity of funds, an amount of **Rs.41,000/-** only was booked by the Executive Engineer, PWD, Mahe during the financial year 2017-18 under the Head of Account shown in the Corrigendum Order.

3. Whereas since the Heads of Account under which the Corrigendum was accorded is inoperative during the current financial year owing to the merger of Plan & Non-Plan Heads of Account, the Executive Engineer, PWD, Mahe is now seeking Corrigendum to the Head of Account to book the balance amount during the current financial year.
